**GENERAL WARRANTY DEED  
JOINT RIGHTS OF SURVIVORSHIP**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **EIGHT HUNDRED TWENTY FIVE THOUSAND AND 00/100 DOLLARS (\$825,000.00)**, and other good and valuable consideration in hand paid to Benny A. Wink and Jeri W. Wink, a married couple (hereinafter referred to as "Grantors"), the receipt and sufficiency of which is hereby acknowledged, by the Daniel Andrew Reeves and Sarah Bishop Reeves, as joint tenants with right of survivorship (hereinafter referred to as "Grantees"), hereby grant, bargain, sell and convey unto Grantees, in fee simple absolute together with every contingent remainder and right of reversion, and subject to all the provisions contained in this warranty deed, the following described real property situated in Shelby County, Alabama, to-wit:

**Lot 203A, according to the Resubdivision of Lots 202, 203, 204, 205, 206, 207, 208, 209 and 210, Stonebridge 2nd Sector, as recorded in Map Book 48, Page 47, in the Probate Office of Shelby County, Alabama.**



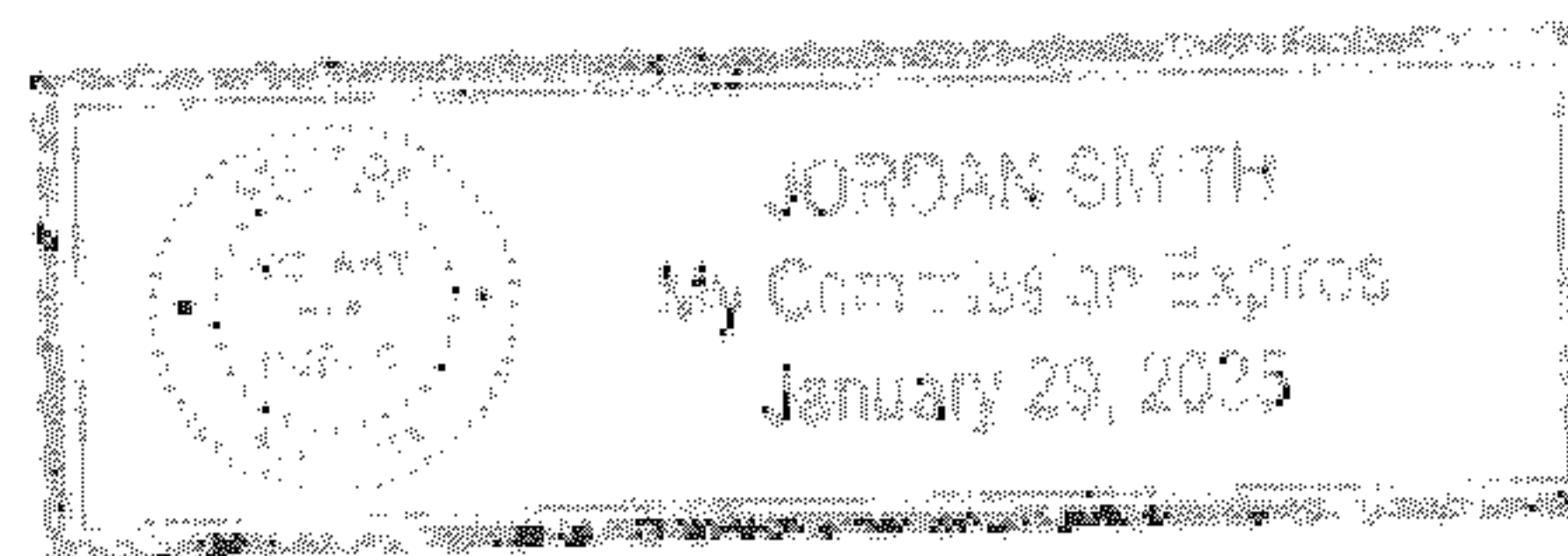
