KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, February 15, 2023, Colby Kiley, a single person and Halle Brooks Hilton, a single person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Movement Mortgage, LLC, which said mortgage was recorded in Instrument No. 20230221000045870 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to Movement Mortgage, LLC by instrument recorded in Instrument No. 20231103000324140 in the aforesaid Probate Office (hereafter "Transferee"); and

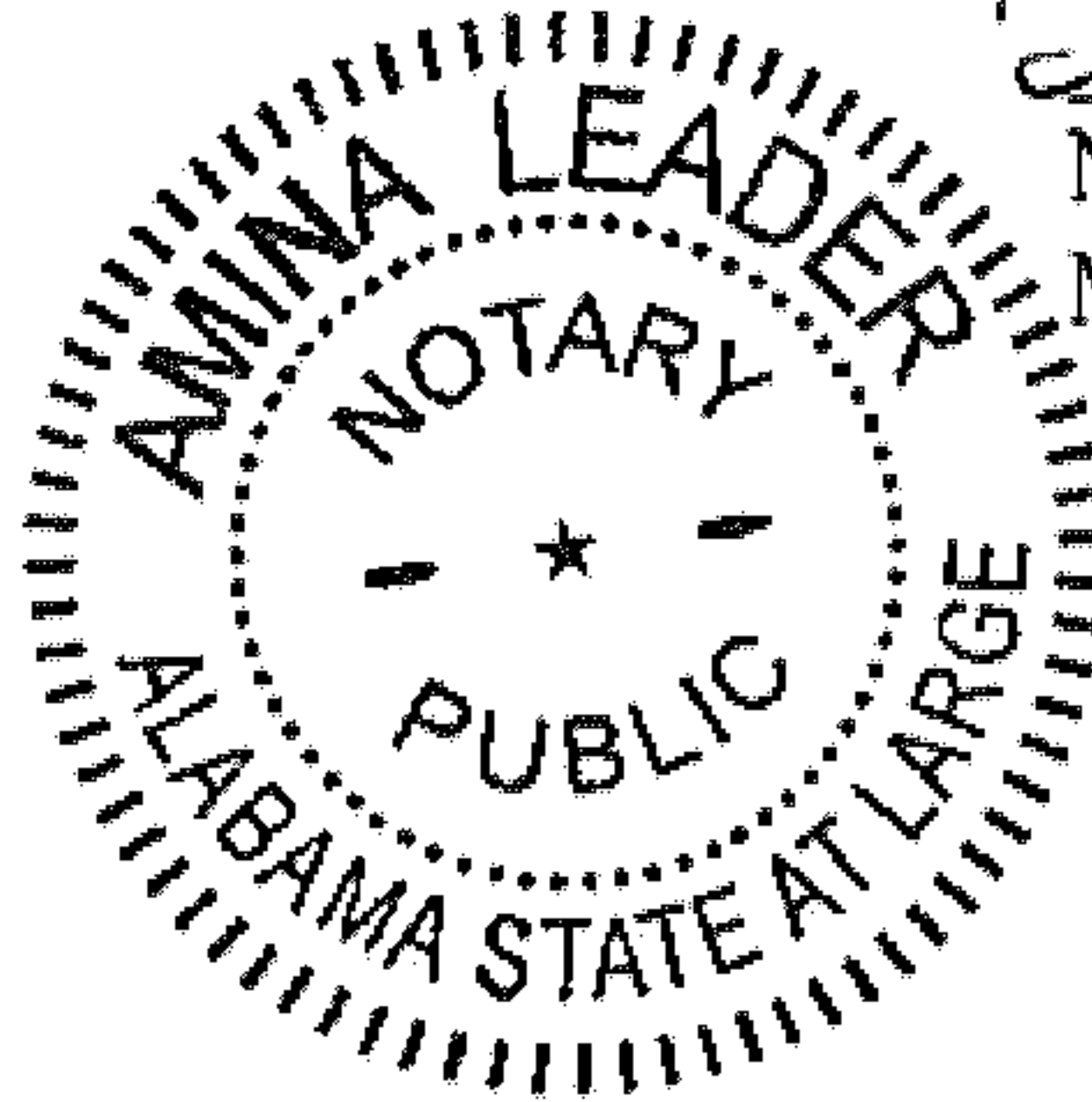

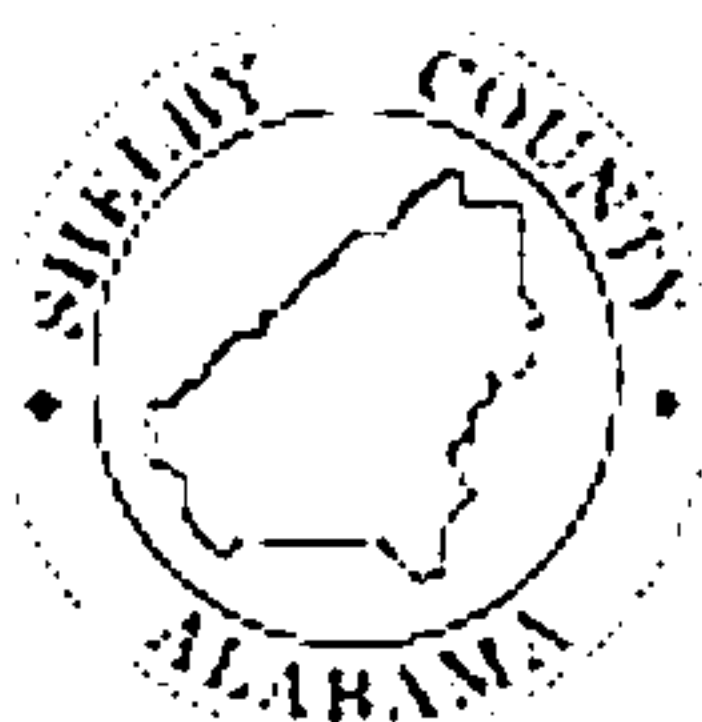
