There have been no amendments limiting the powers of our Trustees over trust property.

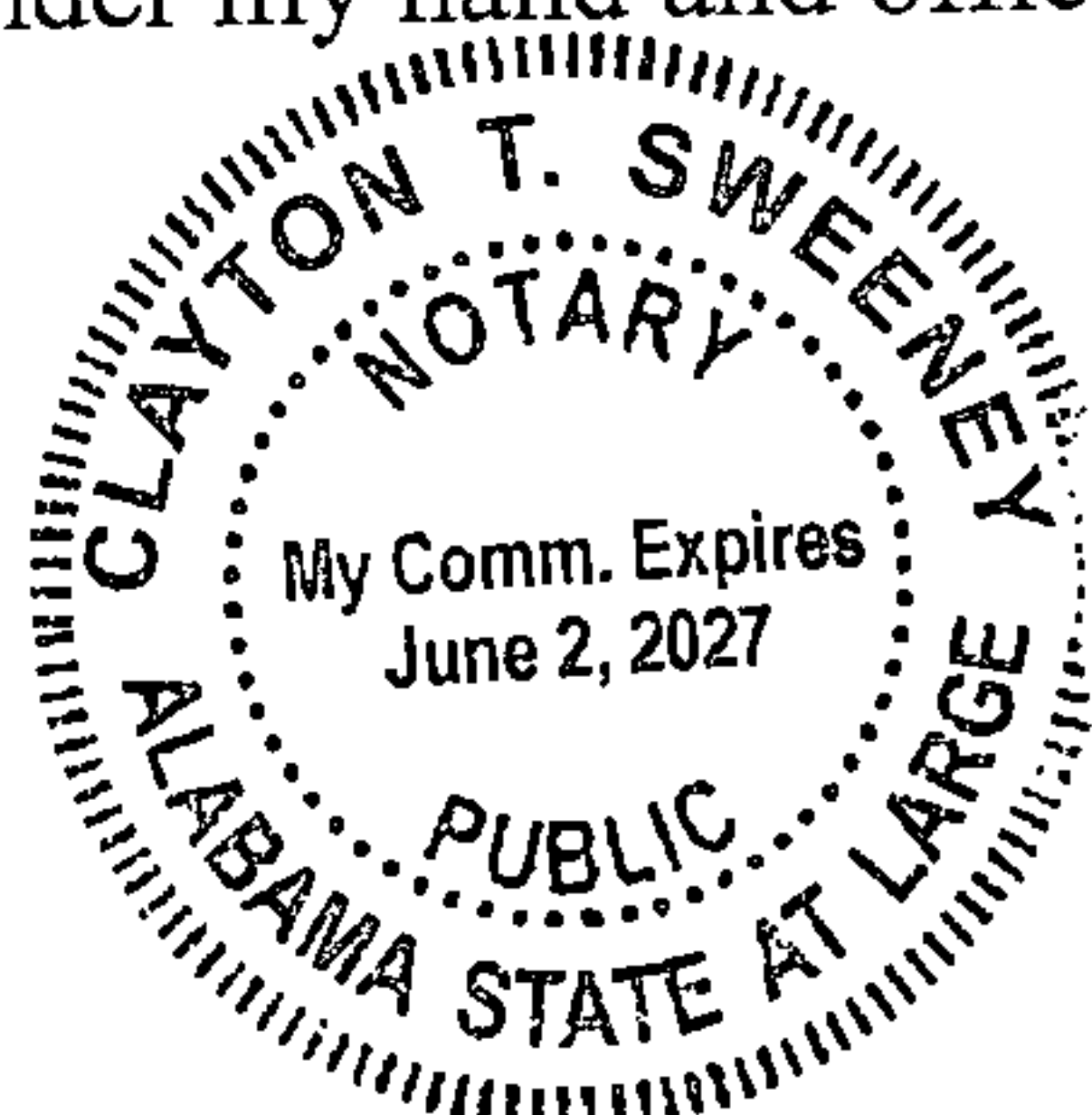
