

**CERTIFICATE OF TRUST
FOR THE ROBERT J. CERFOLIO REVOCABLE TRUST**

THE UNDERSIGNED, being the Grantor and Trustee of the ROBERT J. CERFOLIO REVOCABLE TRUST, dated 6/4, 2020, (hereinafter, the "Trust"), being first duly sworn, does hereby certify to the terms and conditions of the Trust as follows:

SUGGESTED TRUST REGISTRATION. The suggested registration of Trust assets is:

Robert J. Cerfolio, as Trustee
of the Robert J. Cerfolio Revocable Trust,
dated June 4, 2020

ORIGINAL TRUST AND RESTATEMENTS: The Grantor executed the ROBERT J. CERFOLIO REVOCABLE TRUST Agreement on 6/4, 2020.

TAX IDENTIFICATION. The tax identification number of the Trust is the Grantor's social security number.

INVESTMENT POWERS. The Trustee and his successors are not limited in their investment powers and have the same authority to purchase or sell any investment as an individual possesses in the management of his/her own affairs. Said powers without limitation include the power to buy, sell, hold, transfer, or exercise any ownership rights in any asset for the Trust by executing any appropriate documents, or by oral demand to buy or sell a security; to maintain, deposit to or withdraw from any bank, brokerage or mutual fund account and to sign checks or drafts on any such account; to purchase or exercise rights in any life insurance or annuity contracts; and to borrow and pledge any trust asset as security.

TRUSTEE. The initial trustee of the Trust shall be the Grantor, ROBERT J. CERFOLIO ("ROBERT J."). In the event that ROBERT J. is unwilling or unable to act as Trustee, the Grantor's son, ROBERT MICHAEL CERFOLIO ("ROBERT M."), shall serve as successor Trustee. In the event that ROBERT M. is unwilling or unable to act as Trustee, the Grantor's son, ALEC JAMES CERFOLIO ("ALEC"), shall serve as successor Trustee. In the event that ALEC is unwilling or unable to act as Trustee, the Grantor's son, MATTHEW COLE CERFOLIO, shall serve as successor Trustee. The last surviving Trustee in each instance shall have the power to appoint a co-Trustee or successor Trustee to serve in his/her place.

DELEGATION. Either the Grantor or the current Trustee may authorize any person including a successor Trustee to sign on any account or exercise any Trustee power. Said authorization shall continue until written notice of its revocation.

PROTECTION OF PERSONS DEALING WITH THE TRUSTEE. Any person who is in possession of a photocopy of this Certificate may in good faith rely upon the information it contains and shall not be liable to the Grantor, any Trustee or beneficiary for transactions based upon this Certificate. Further, any person shall assume the authority of the Trustee to act and shall not require the approval of the Grantor, any beneficiary, or any court to any transaction.

TRUST IS REVOCABLE. The Trust is revocable and amendable by the Grantor during the Grantor's lifetime.

ADDITIONAL CERTIFICATION. Any person may rely upon the certification of any Trustee as to matters which are not contained in this Certificate, including further enumeration of Trustee powers.

NOTICE. No person shall have received notice of any event upon which the use of this Certificate depends unless said notice is in writing and until the notice is delivered to said person.



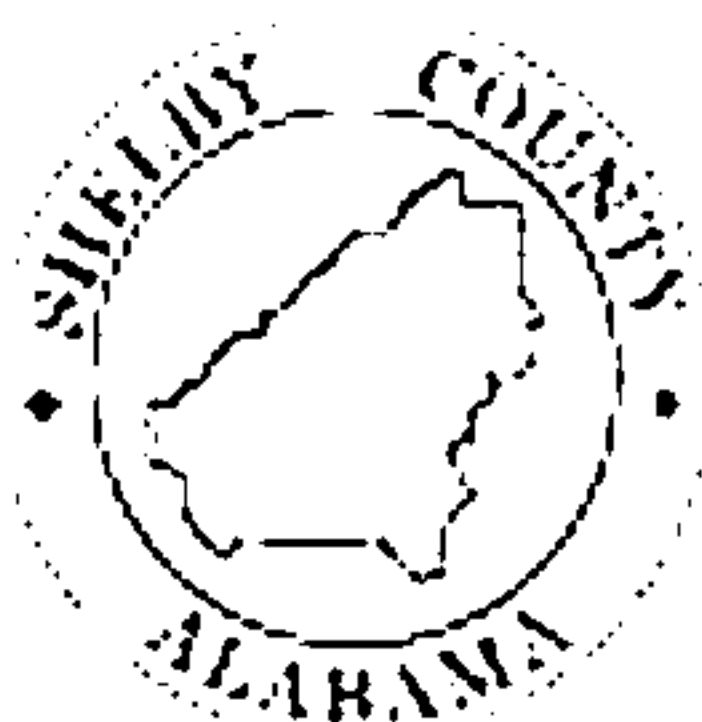
