KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three Hundred Thirty Thousand And No/100 Dollars (\$330,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Estate of Jerry B. Saucier a/k/a Jerry Batson Saucier, deceased (Shelby County, Alabama Probate Case No. PR-2023-000858) (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Talmadge Dean Thomason, III and Lauren Alicia Thomason (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 48, according to the survey of Dearing Downs, 6th Addition, Phase I, as recorded in Map Book 10, Page 78 in the Office of the Judge of Probate of Shelby County, Alabama.

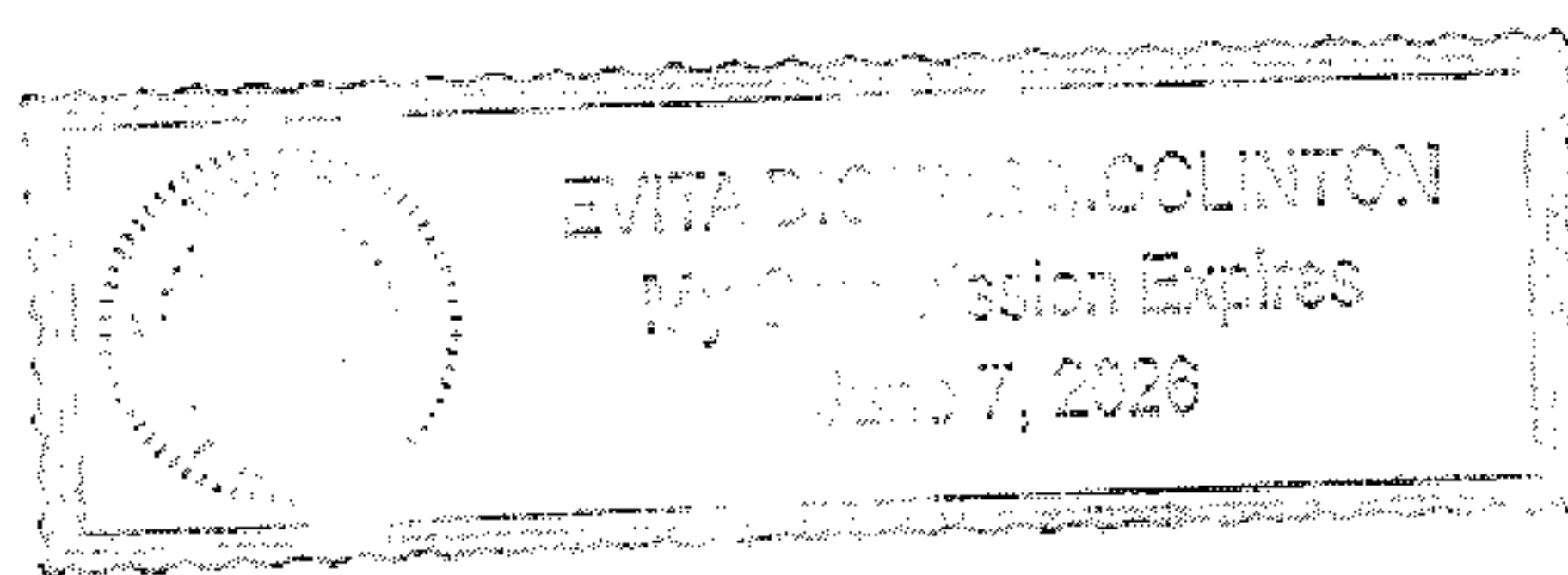



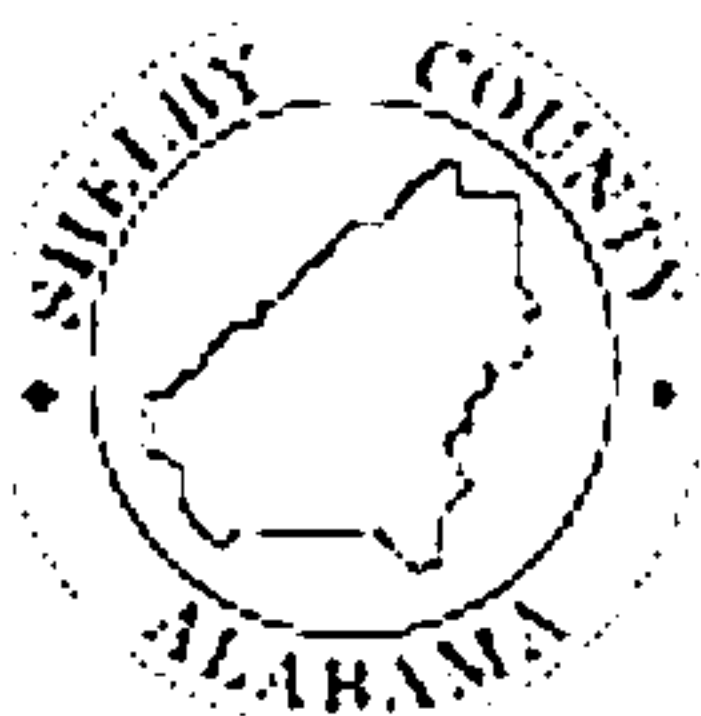
