That in consideration of the sum of **Nine Hundred Twenty Five Thousand Dollars and No Cents (\$925,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Michael J. Nicholas and Wanda L. Nicholas, husband and wife**(herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Patrick Barberio and Patricia Barberio**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

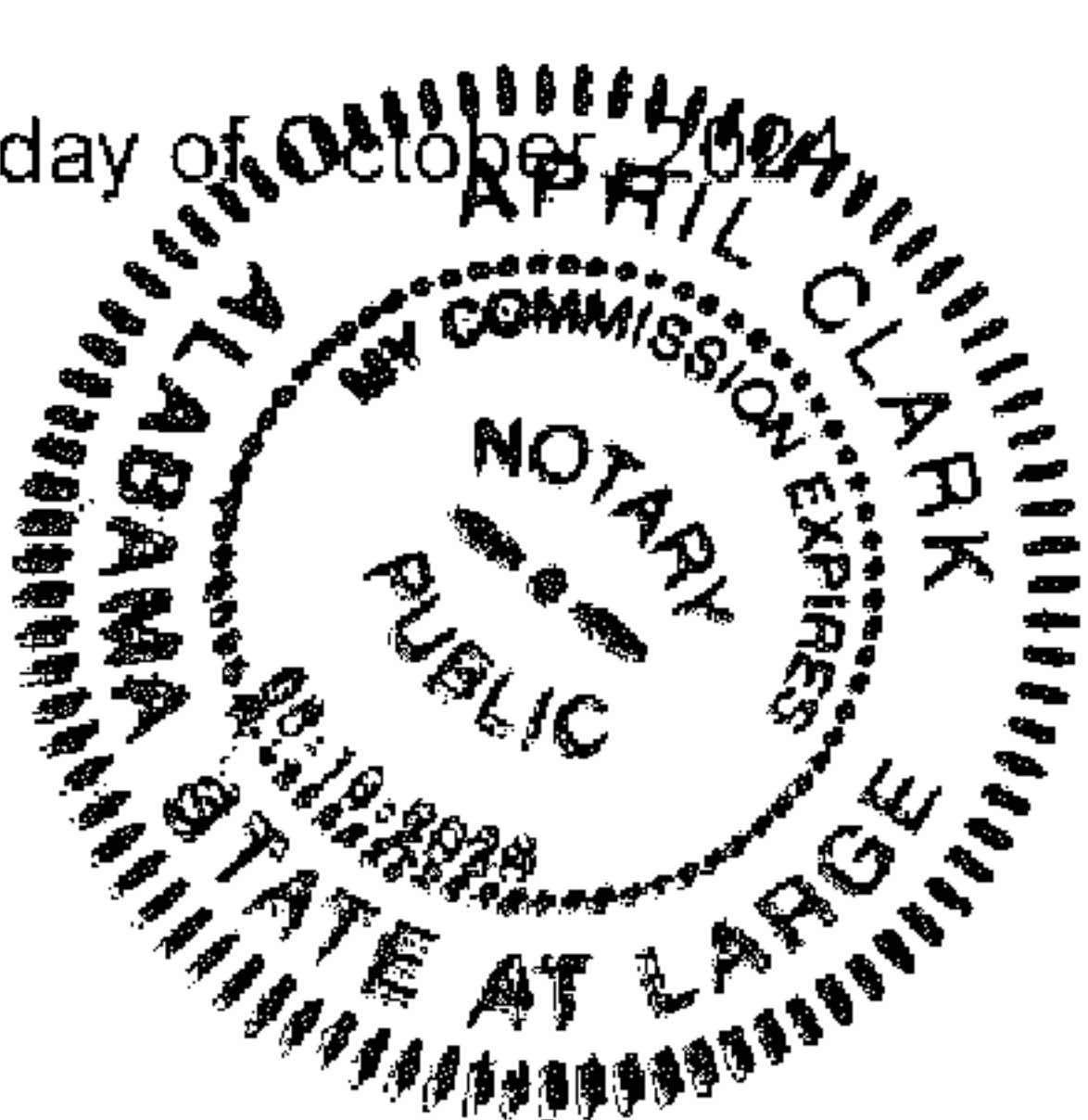
