KNOWN ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, to-wit, on July 29, 2022, CRAIG GOLDEN, A MARRIED MAN, as Mortgagor(s), executed a Real Estate Mortgage on the property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC., AS NOMINEE FOR DHI MORTGAGE COMPANY, LTD., which is recorded in Instrument Number 20220801000299430 on August 1, 2022, in the Office of the Judge of Probate, Shelby County, Alabama and subsequently assigned to Carrington Mortgage Services, LLC and recorded in Instrument Number 20240815000254930 on August 15, 2024; and,

WHEREAS, on October 3, 2024, the day on which the foreclosure was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure was duly and properly conducted, and the said Mortgagee did offer for sale and sell at public outcry in front of the door of the Courthouse of Shelby County, Alabama, the property hereinafter described; and,

WHEREAS Susie Nailen was the Auctioneer who conducted said foreclosure sale and was the person conducting said sale for the said Mortgagee; and,


