KNOW ALL MEN BY THESE PRESENTS, That in consideration **ONE HUNDRED SIXTY FIVE THOUSAND DOLLARS AND ZERO CENTS (\$165,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Mondragon Properties, LLC (herein referred to as Grantor)** grant, bargain, sell and convey unto **Santos Reyes Hernandez and Katherin Esmeralda Asisclo Quevedo, as joint tenants with right of survivorship (herein referred to as Grantees)**, the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:



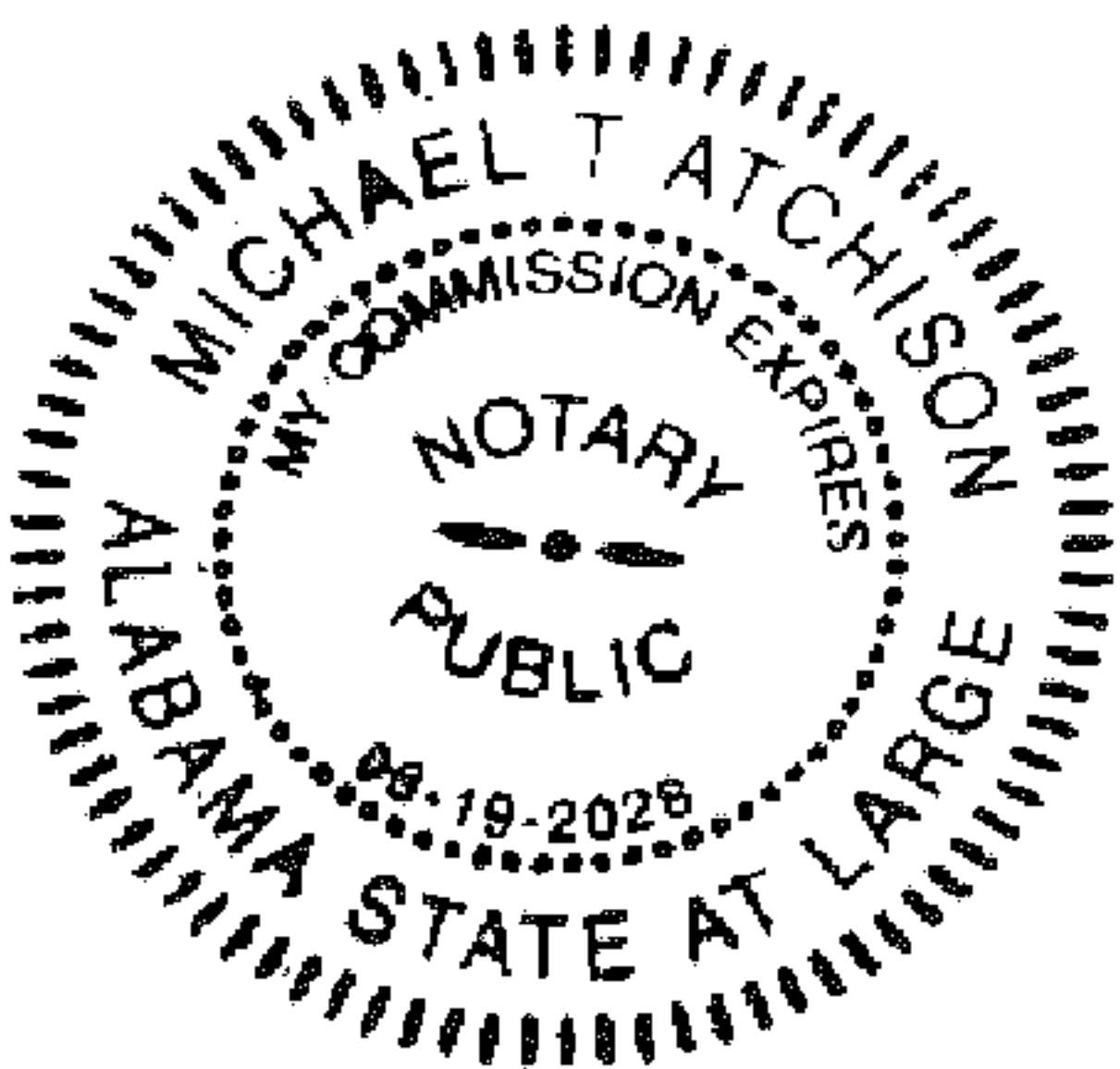

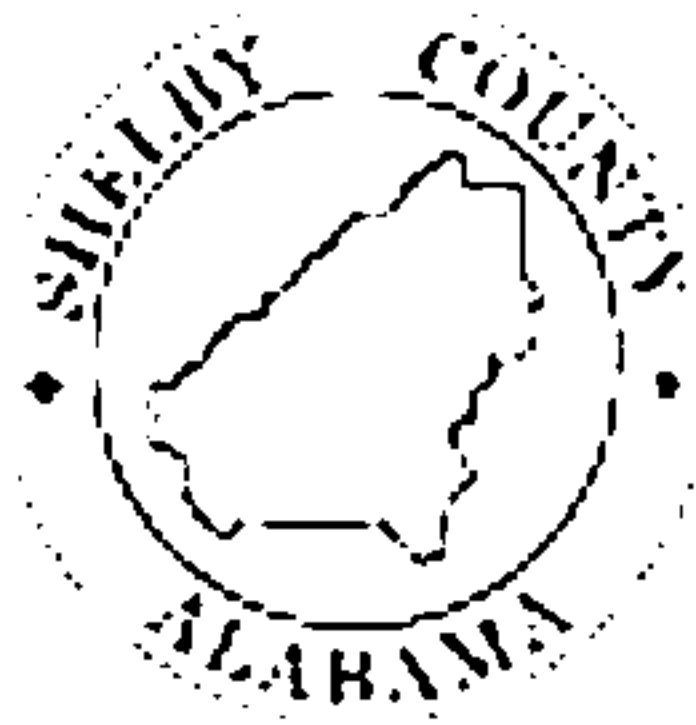
