KNOW ALL MEN BY THESE PRESENTS: That,



The rights, powers, and authority of my said Attorney-in-Fact herein granted shall commence and be in full force and effect on October 23, 2024; the authority conferred herein shall not be affected by disability, incompetency, or incapacity of the said principal, Mary Lee Reynolds; and such rights, powers and authority shall remain in full force and effect thereafter until this power is revoked by written notice from the principal to the Attorney-in-Fact. Any action taken in good faith pursuant to the foregoing shall be binding upon me, my heirs, assigns and personal representatives.

If Holly Kristin Hoyle ceases to act as Attorney-in-Fact by reason of death, incapacity or resignation, I appoint Heidi Smiley as Attorney-in-Fact. The resignation of the original Attorney-in-Fact may be evidenced by an instrument in writing delivered to the successor Attorney-in-Fact above named. The incapacity of the original Attorney-in-Fact may be determined by a statement of a physician delivered to the successor Attorney-in-Fact.
