WHEREAS that certain Declaration of Covenants, Conditions and Restrictions for Holland Place Owners Association, Inc. (hereinafter "Association"), recorded in the Probate Office of Shelby County, Alabama (hereinafter "Declaration") provides for a lien against the property located at **464 Holland Lakes Drive North, Pelham, AL 35124** (hereinafter "Property") for the benefit of the Association to secure the payment of assessments levied against the Property for common expenses and fees.

WHEREAS the Declaration provides that the Association is vested with the power to assess, collect assessments, and enforce the lien retained against the Property.

WHEREAS according to the Association's records, **JONATHAN W. BURCH AND MEREDITH D. BURCH**, (hereinafter "Owner," whether one or more) is the Owner of the Property legally described as follows:

Lot 33, according to the Final Plat of Holland Lakes, Sector Two, Phase 1, as recorded in Map Book 36, Page 8, in the Probate Office of Shelby County, Alabama (the "Property"); being situated in Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Areas as more particularly described in Holland Place Declaration of Covenants, Conditions, and Restrictions executed by the Grantor and filed for record as Instrument No. 2005046000199570 in the Probate Office of Shelby County, Alabama (the "Declaration").

WHEREAS Owner is in default in the Owner's obligations to make payments for assessments and has failed, despite demand upon the Owner, to pay Association assessments, handling charges, and collection costs properly levied against the Property, in the amount as of 10/17/2024 equal to \$820.02, which amount may continue to increase.


