

7. Protection of Lender's Security. THIS PLANNED UNIT DEVELOPMENT RIDER is made this 22nd day of October, 2024, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date, given by the undersigned (the "Borrower") to secure Borrower's Note to Discover Bank (the "Lender") of the same date and covering the Property described in the Security Instrument and located at: 641 Foothills Trace, Chelsea, AL 35.043

The Property includes, but is not limited to, a parcel of land improved with a dwelling, together with other such parcels and certain common areas and fecilities, as described in THE COVENANTS, CONDITIONS AND RESTRICTIONS FILED CE RECORD THAT AFFECT THE PROPERTY. (the "Declaration"). The Property is a part of a planned unit development known as FOOTHILLS CHASE (the "PUD"). The Property also includes Borrower's interest in the homeowners association or equivalent entity owning or managing the common areas and facilities of the PUD (the "Owners Association") and the uses, benefits and proceeds of Borrower's interest.

generally accepted insurance carrier, a "master" or "blanket" pelicy insuring the Property which is satisfactory to Lender and which provides insurance coverage in the amounts (including deductible levels), for the periods, and against loss by fire, hazards included within the term "extended coverage," and any other hazards, including, but not limited to, earthquakes and floods, for which Lender requires insurance, then Borrower's obligation under Uniform Covenant 5 to maintain property insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy.
