7. Remedies.

The notice will specify, in addition to any other information required by applicable law: (i) the default; (ii) the action required to cure the default; (iii) that failure to cure the default on or before the date specified in the notice may result in the sale of the Property; and (iv) Borrower's right to bring a court action to deny the existence of a default or to assert any other defense of Borrower to the sale.
- (b) Power of Sale; Expenses. If the default is not cured on or before the date specified in the notice, Lender, without further demand, may invoke the power of sale and any other remedies permitted by applicable law. Lender will be entitled to collect all expenses incurred in pursuing its remedies, including, but not limited to: (i) reasonable attorneys' fees and costs; and (ii) other fees incurred to protect Lender's interest in the Property and/or rights under this Security Instrument.
- (c) Notice of Sale; Sale of Property. If Lender invokes the power of sale, Lender will give a copy of any notice to Borrower required by applicable law. 
