KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of September, 1987, William H. White and Brenda T. White, Husband and Wife, executed that certain mortgage on real property hereinafter described to United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Book 155 Page 789, said mortgage having subsequently been transferred and assigned to Secretary, United States Department of Agriculture, Rural Development ("Transferee"); and

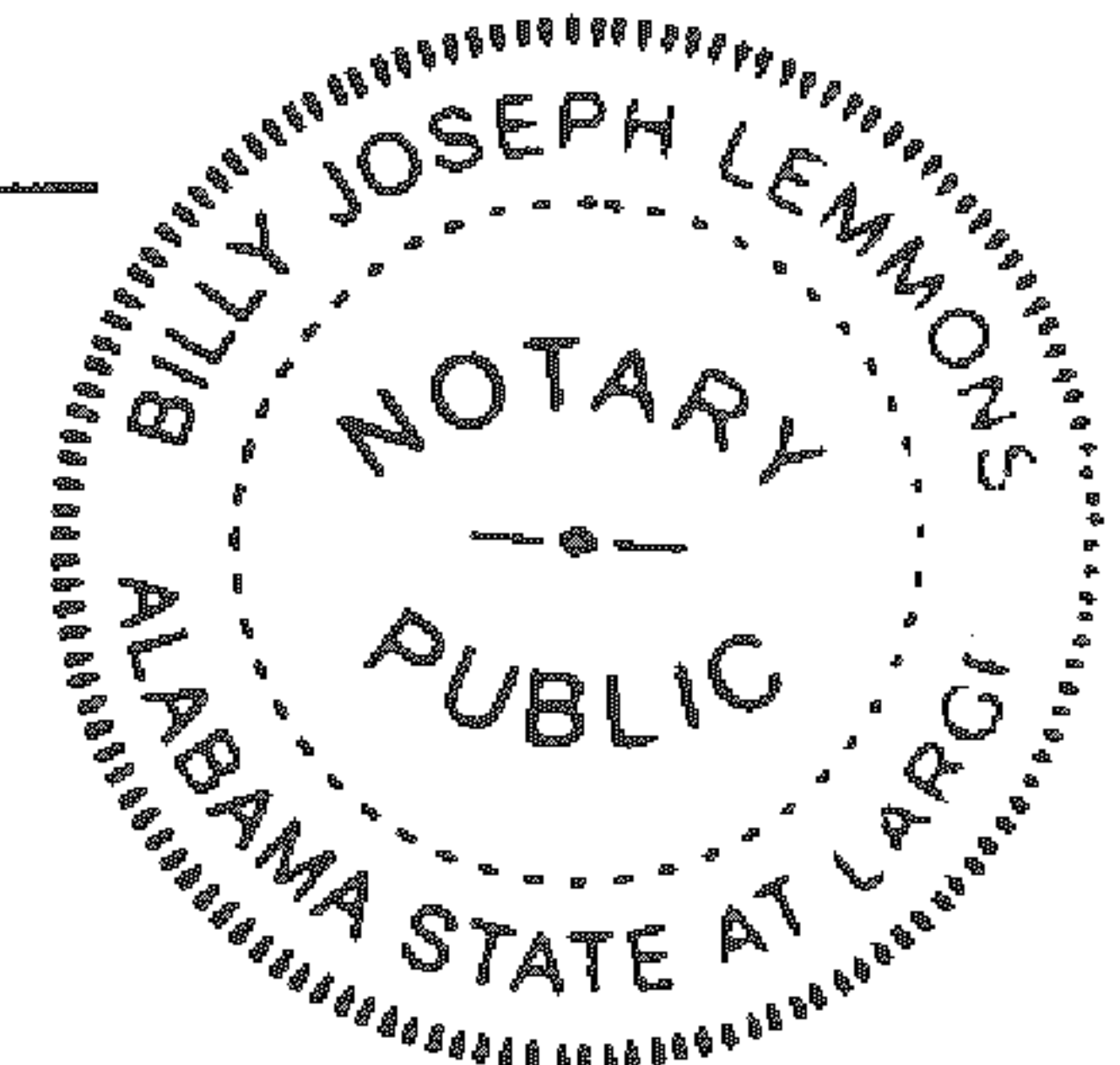
