Pursuant to the terms of the Trust, any person may rely upon this Certificate of Trust as evidence of the existence and validity of said Trust, and is relieved of any obligation to verify that any transaction entered into by a Trustee or Successor Trustee thereunder is consistent with the terms and conditions of said Trust.**

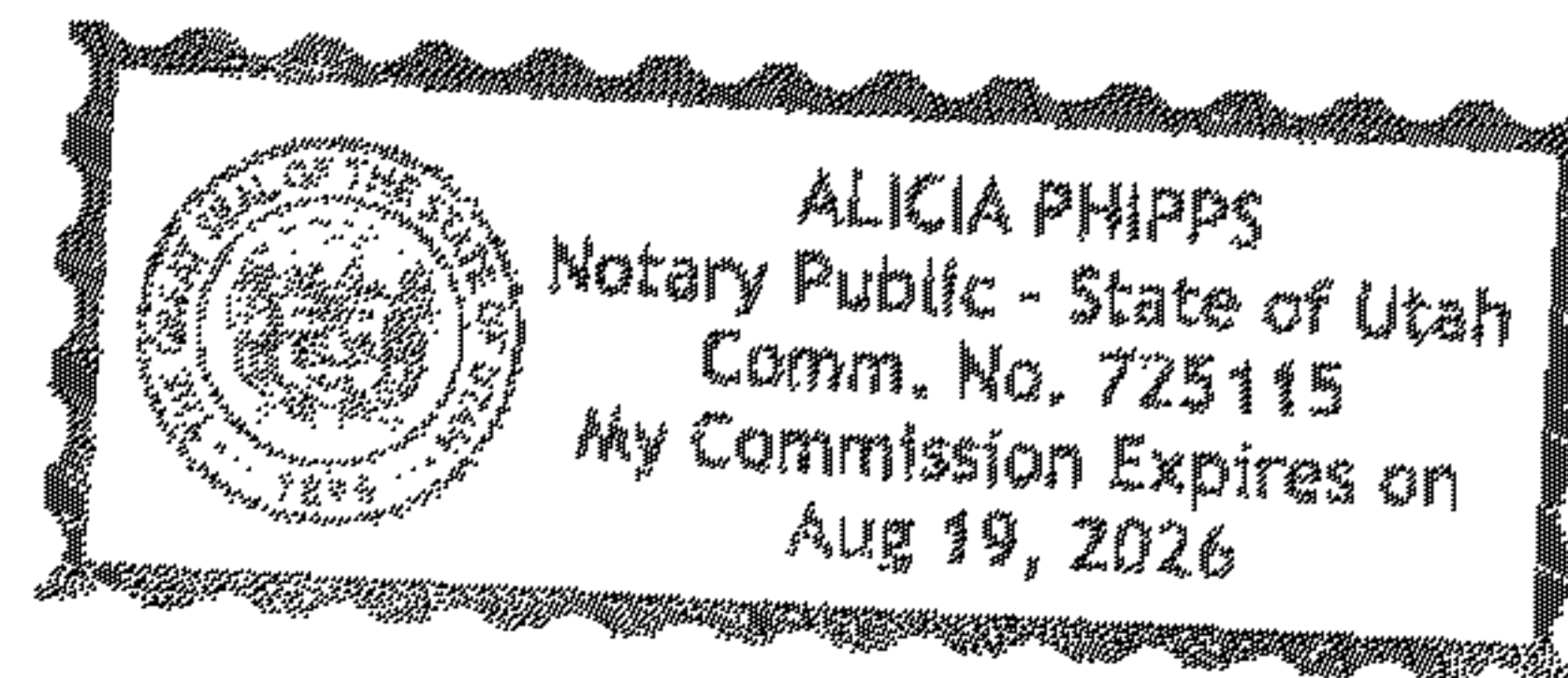
