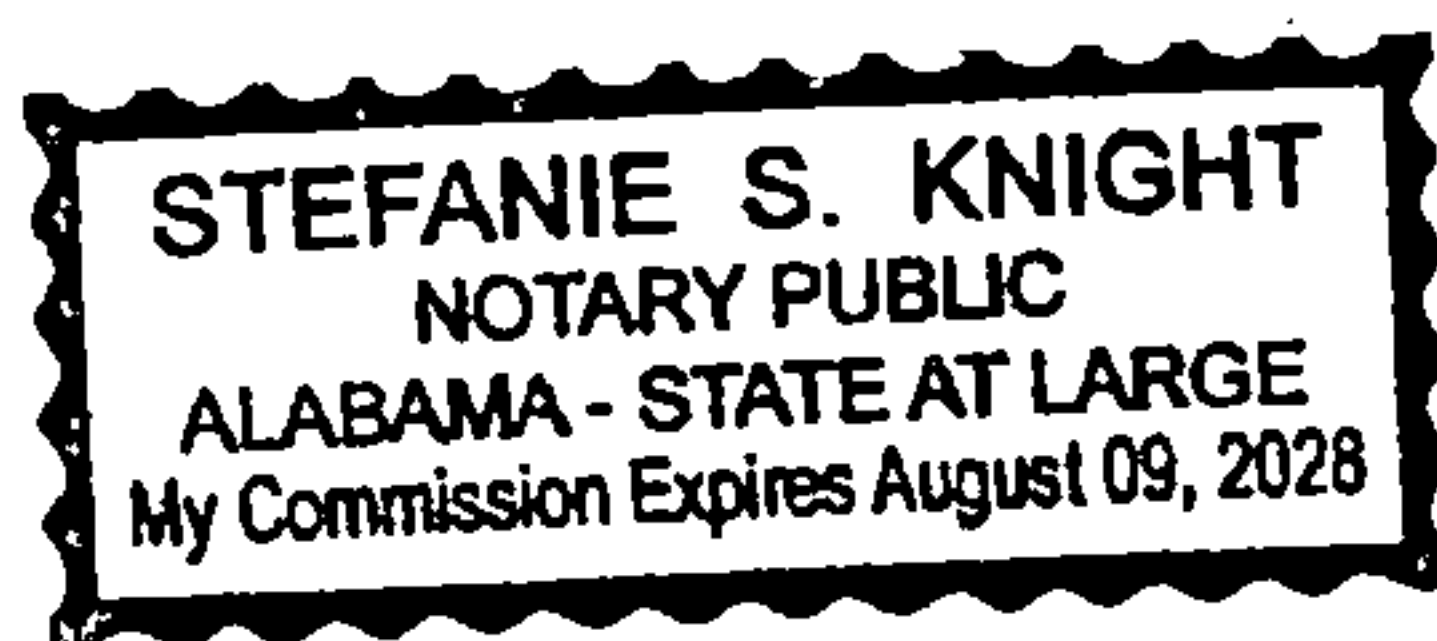
KNOW ALL MEN BY THESE PRESENTS:

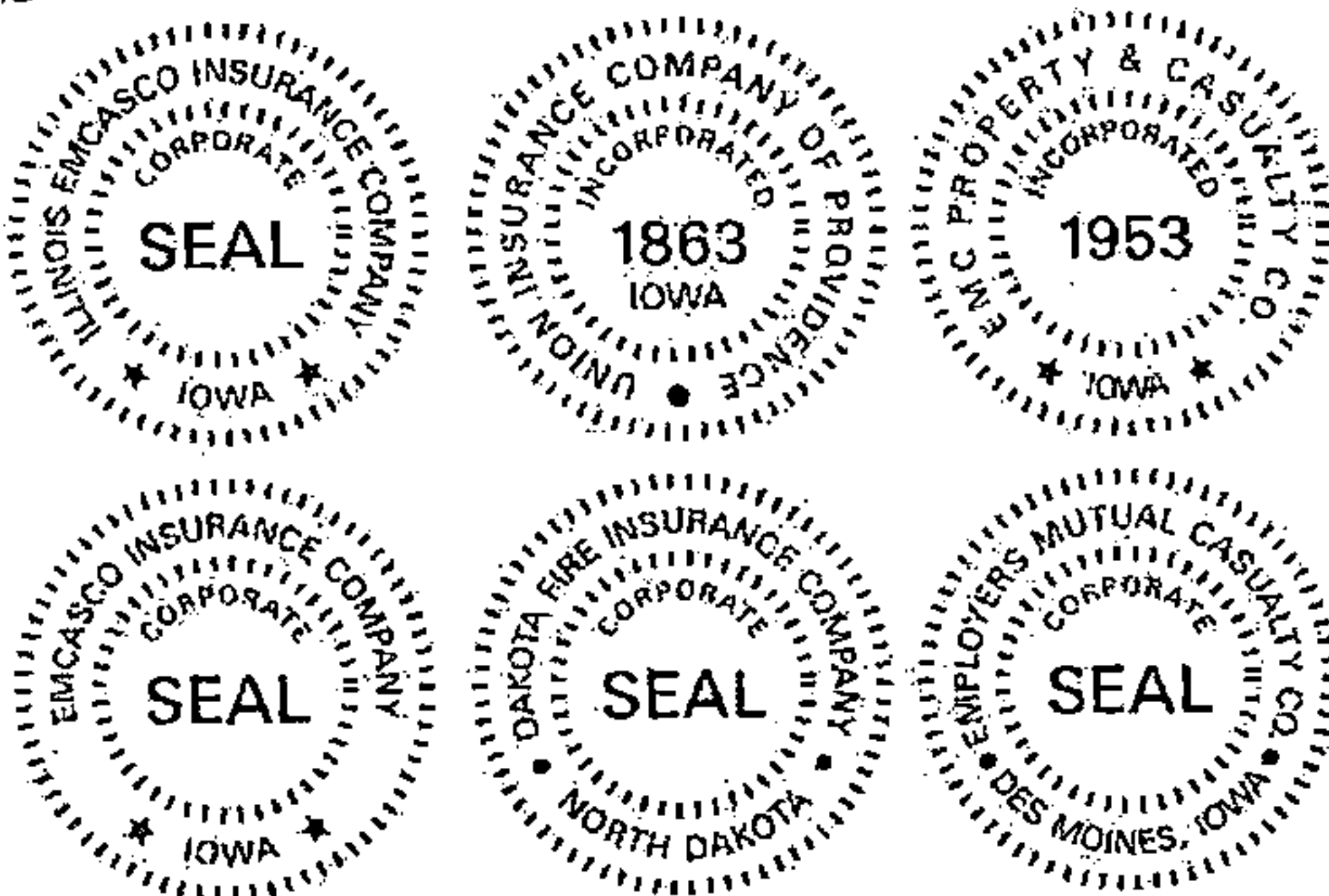
AUTHORITY FOR POWER OF ATTORNEY
