**GENERAL WARRANTY DEED**  
**With Right of Survivorship**

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of THREE HUNDRED FIVE THOUSAND AND 00/100 (\$305,000.00), and other good and valuable consideration in hand paid to John B. Hilley, a married man conveying property that is not his homestead nor that of his spouse, (hereinafter referred to as "Grantor(s)"), the receipt and sufficiency of which is hereby acknowledged, by the Joshua James Goins and Dominique Goins, husband and wife (hereinafter referred to as "Grantee(s)"), Grantor(s) hereby GRANT(S), BARGAIN(S), SELL(S) and CONVEY(S) unto Grantee(s), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

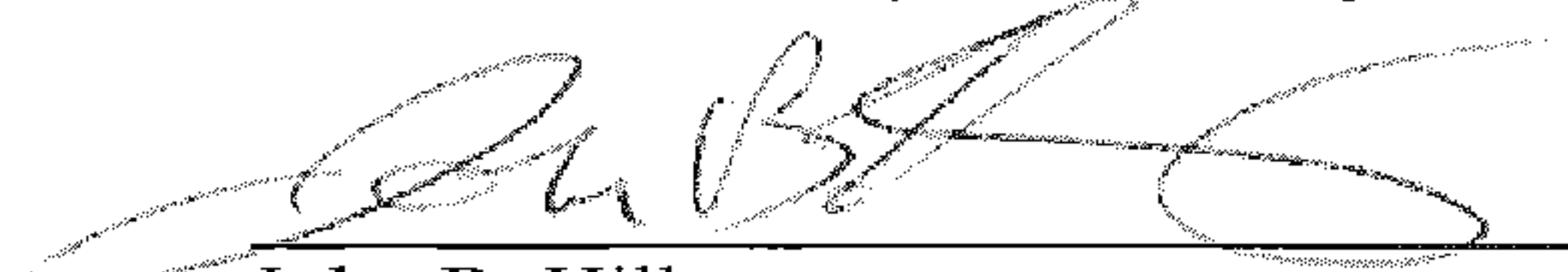
Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

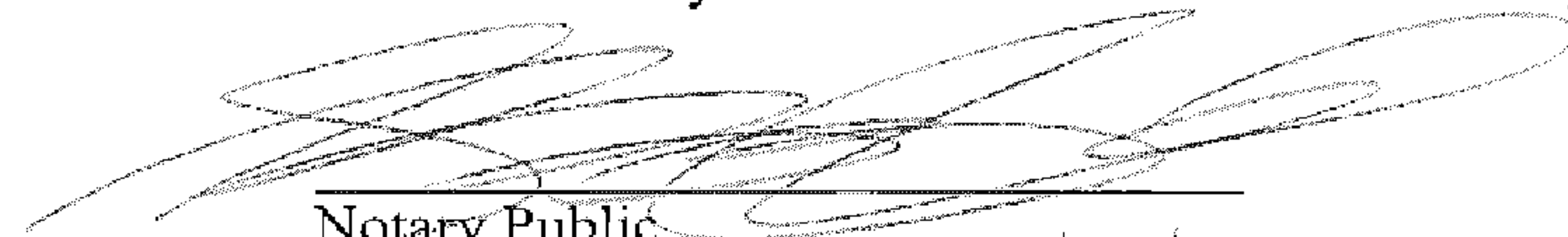

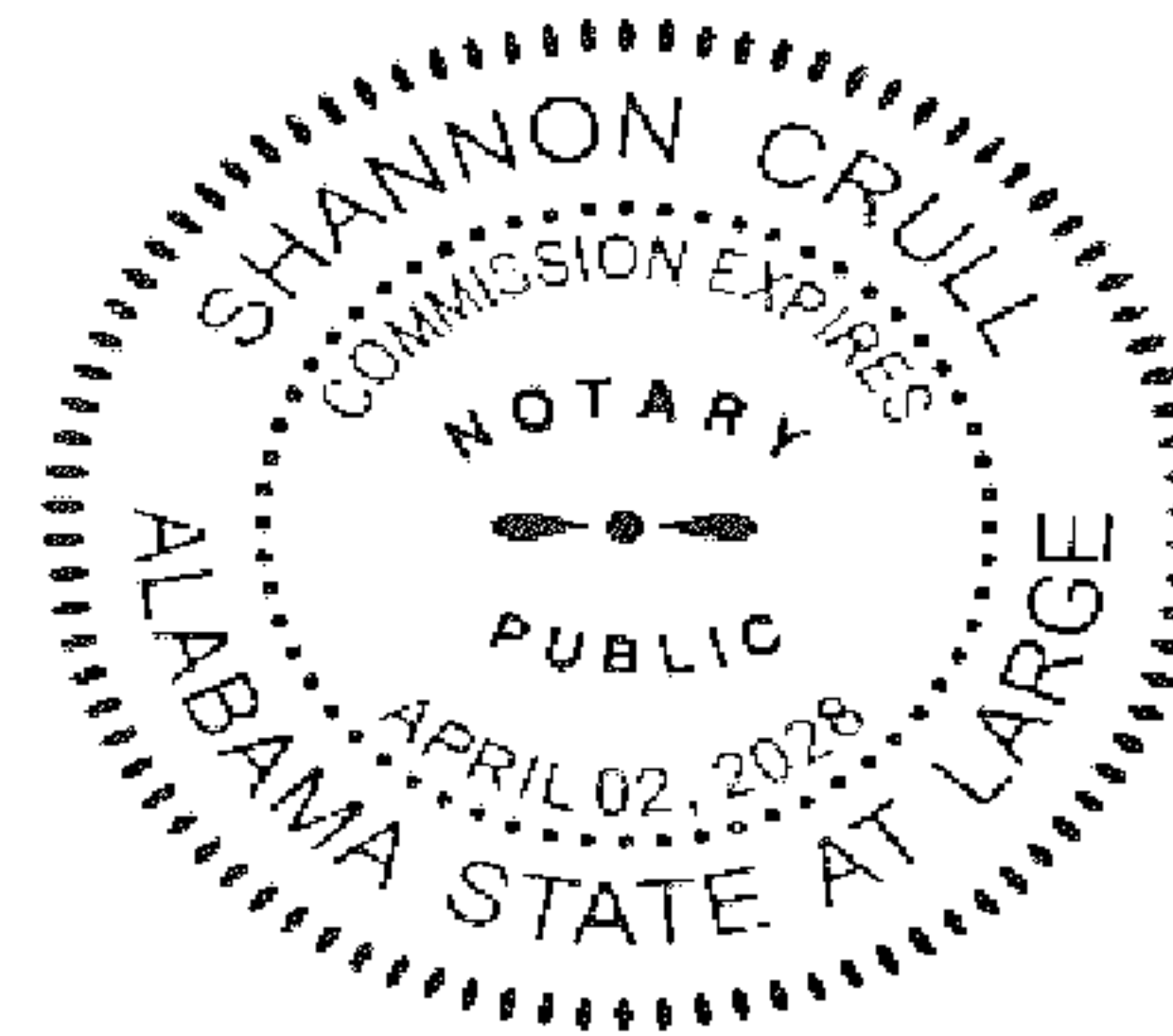
