Know All Men by These Presents: That in consideration of **Five Hundred Forty-Eight Thousand and 00/100 Dollars (\$548,000.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt where is acknowledged, **DONOVAN BUILDERS, LLC** (herein referred to as Grantor), grant, bargain, sell and convey unto **ARAM PEREZ and SANDRA I. PEREZ** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

Lot 706, according to a Resurvey of Lots 705 and 706 of Grey Oaks Sector 7, as recorded in Map Book 59, Page 76, in the Probate Office of Shelby County, Alabama.

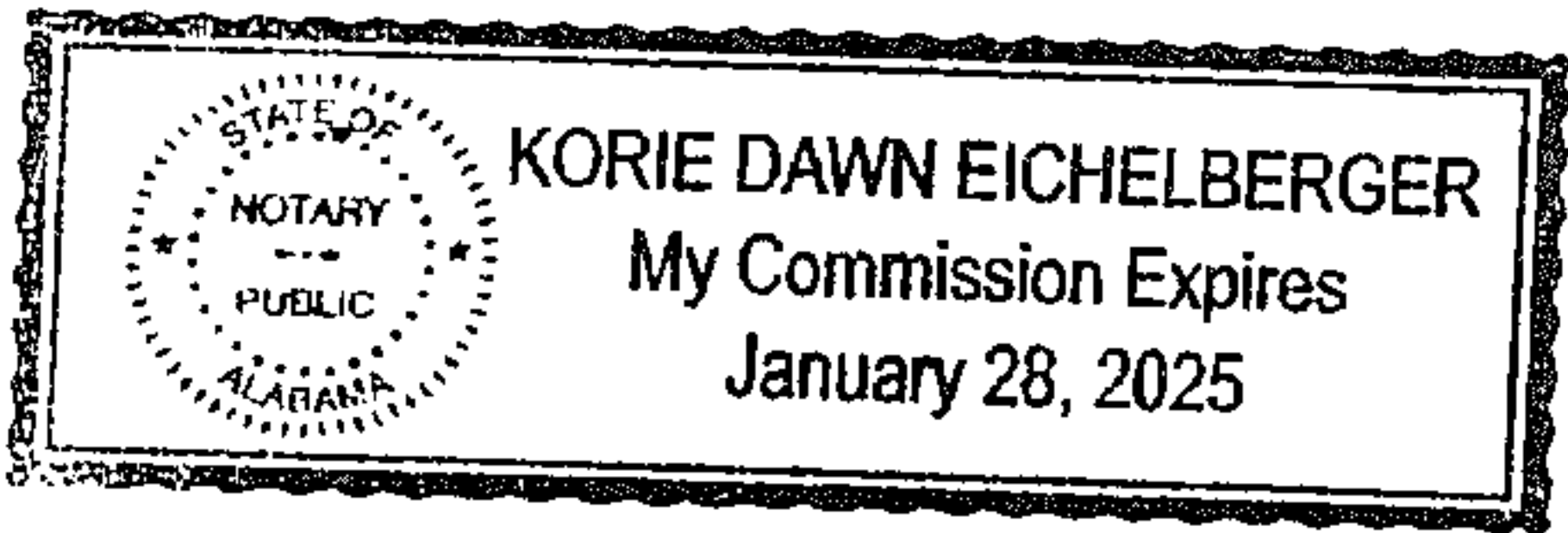

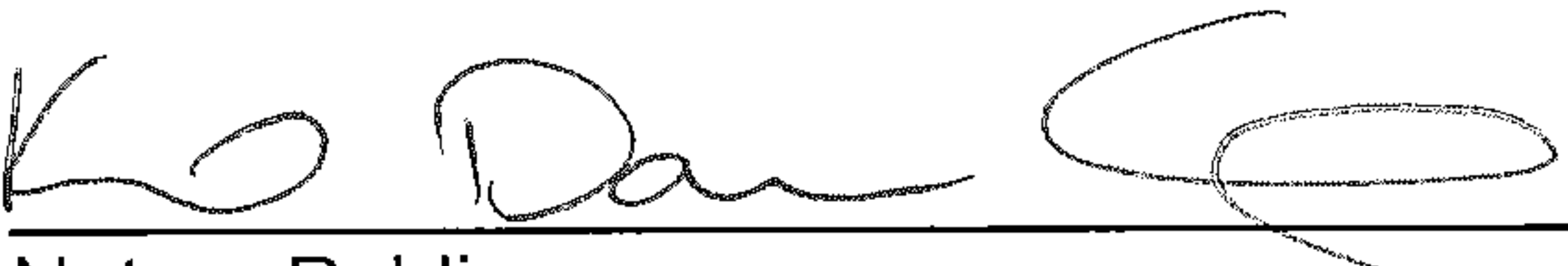

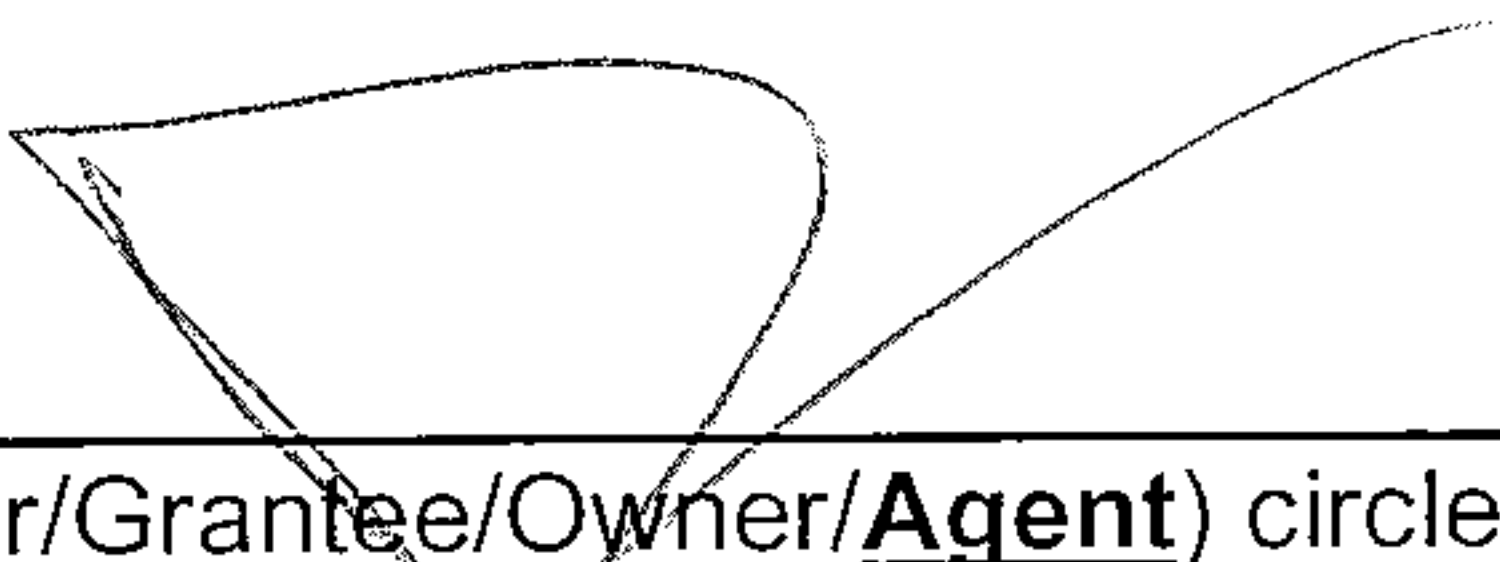
