GENERAL WARRANTY DEED
With Right of Survivorship

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of TWO HUNDRED EIGHTY FIVE THOUSAND AND 00/100 (\$285,000.00), and other good and valuable consideration in hand paid to Glenda Brown, a married woman (hereinafter referred to as "Grantor(s)"), the receipt and sufficiency of which is hereby acknowledged, by the Sara Martin and Cody Martin, wife and husband (hereinafter referred to as "Grantee(s)"), Grantor(s) hereby GRANT(S), BARGAIN(S), SELL(S) and CONVEY(S) unto Grantee(s), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 102, according to the Survey of Summer Brook, Sector 5, Phase 1, as recorded in Map Book 21, Page 53, in the Probate Office of Shelby County, Alabama.


Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.



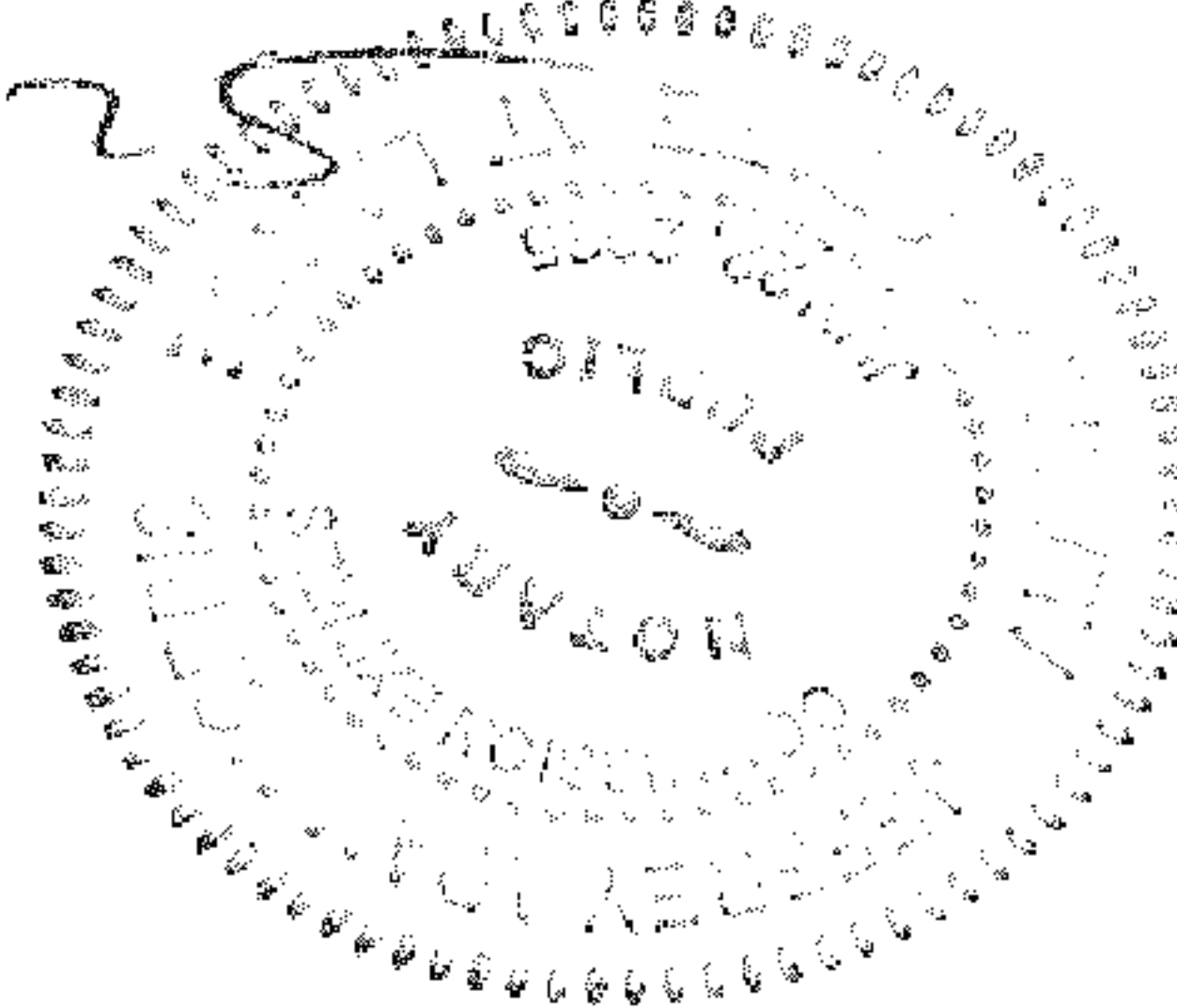
