KNOW ALL MEN BY THESE PRESENTS, That in consideration ONE THOUSAND DOLLARS AND NO/00 DOLLARS (\$1000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Connie G. Channin, a woman and Ronnie W. Gillen, a man** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **Paula K. Holcombe and Roy Holcombe, Jr., as joint tenants with right of survivorship** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

Commence at the SE Corner of the SE 1/4 of the NW 1/4 of Section 14, Township 21 South, Range 2 West, Shelby County, Alabama; thence N00°02'57"E a distance of 362.94'; thence N00°00'46"W a distance of 230.85' to the POINT OF BEGINNING; thence N00°04'01"E a distance of 117.42'; thence N60°46'33"W a distance of 187.82'; thence S14°53'02"W a distance of 76.95'; thence S53°42'59"E a distance of 227.70' to the POINT OF BEGINNING.

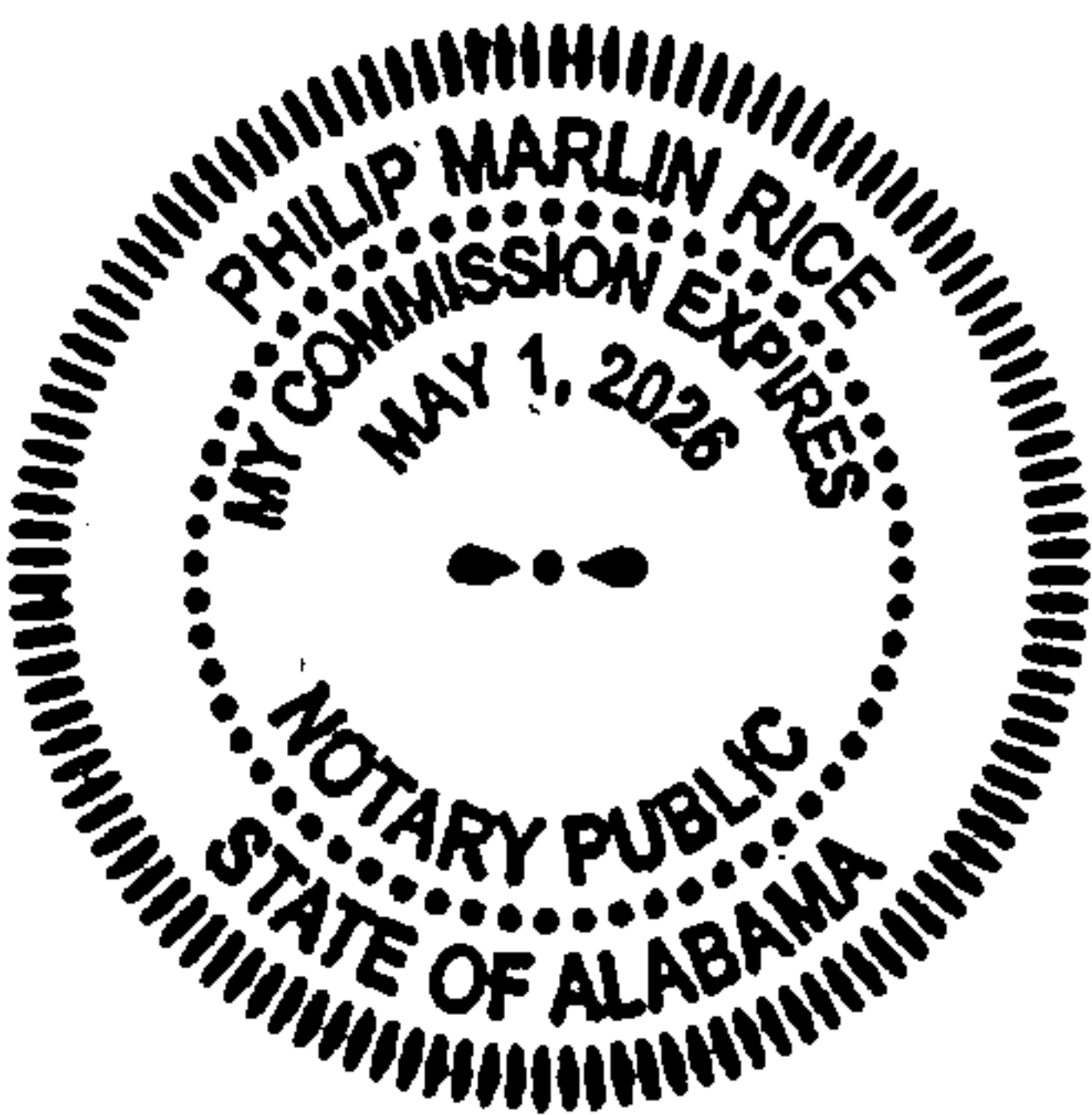

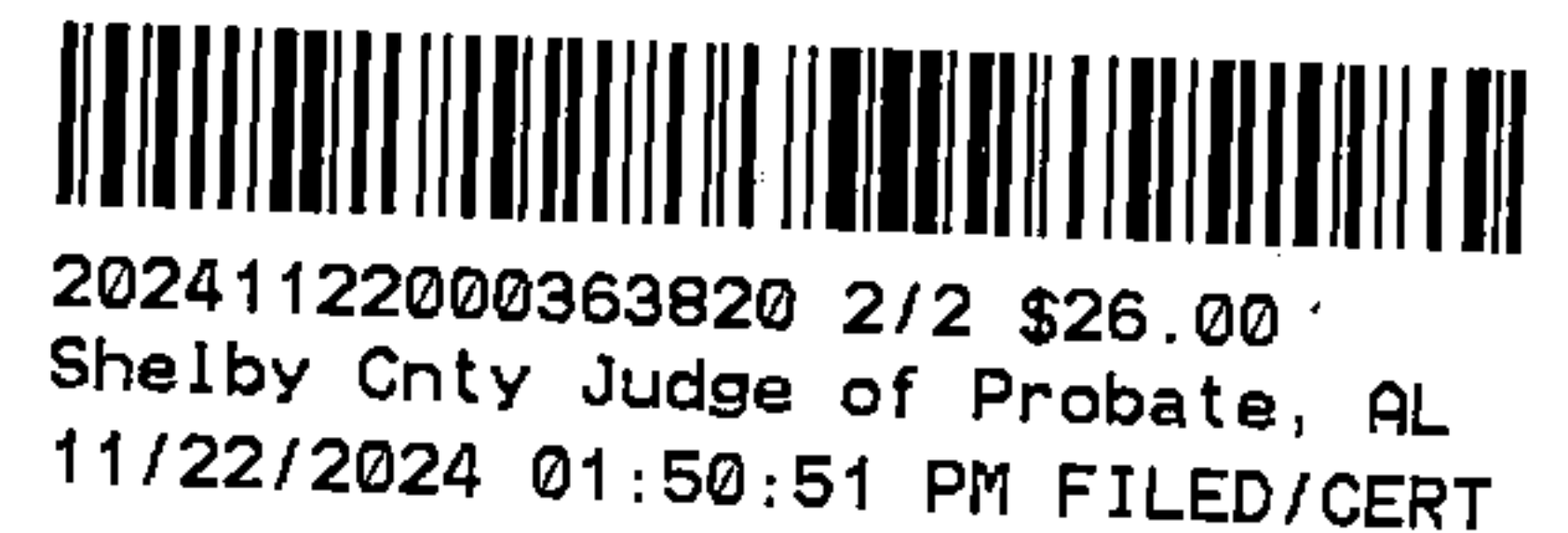
