**GENERAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **ONE HUNDRED EIGHTY SIX THOUSAND AND 00/100 DOLLARS (\$186,000.00)**, and other good and valuable consideration in hand paid to Jenna Catherine Hosemann a/k/a Jenna Hosemann Hassett, a single woman (hereinafter referred to as "Grantor"), the receipt and sufficiency of which is hereby acknowledged, by the Christian Alexander Peters and Sarah Paul, as joint tenants with right of survivorship (hereinafter referred to as "Grantees"), hereby grants, bargains, sells and conveys unto Grantees, in fee simple absolute together with every contingent remainder and right of reversion, and subject to all the provisions contained in this warranty deed, the following described real property situated in Shelby County, Alabama, to-wit:





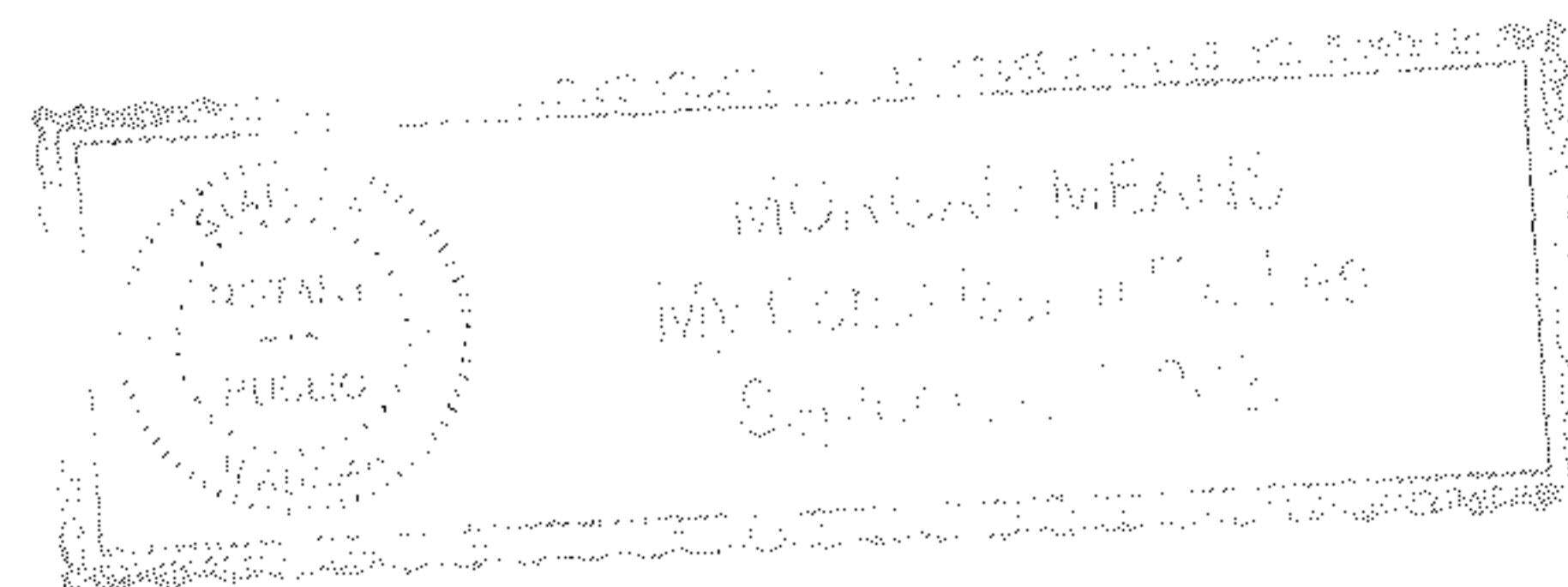
