TRUSTEE'S AND PERSONAL REPRESENTATIVE'S DEED

WHEREAS, Rosella Marie Williams (the "Decedent") died testate at Shelby, Alabama, on or about the 3rd day of February, 2024, and at the time of her death was an inhabitant of Shelby County, Alabama. The Last Will and Testament of Rosella Marie Williams, deceased (the "Will"), was duly probated and admitted to record in the Probate Court of Shelby County, Alabama, in Case Number PR-2024-000210. Letters Testamentary were issued to Jackie Ray Williams, as the Personal Representative of the Estate of Rosella Marie Williams, deceased (the "Personal Representative"), on March 6, 2024.

WHEREAS, the Decedent created a trust pursuant to that certain instrument titled the Rosella M. Williams Management Trust (the "Mrs. Williams Management Trust"), created pursuant to an instrument dated May 20, 1999, as most recently amended and restated pursuant to an instrument dated August 28, 2020 (the "Mrs. Williams Trust Instrument").

WHEREAS, the Decedent served as trustee of the Mrs. Williams Management Trust until her death, at which time, Jackie Ray Williams succeeded her as trustee.

WHEREAS, the Trustee of the Mrs. Williams Management Trust owns a one-half interest in the real property located in Shelby County, Alabama, as described below (the "Property").

WHEREAS, the terms of the Mrs. Williams Trust Instrument provide that upon the death of the Decedent, the assets held under the terms of the Mrs. Williams Trust Instrument are due to be transferred to the Decedent's spouse, Jackie R. Williams, outright and free of trust.

WHEREAS, the terms of **ARTICLE VI** of the Will provide that the residue of the Decedent's Estate is due to be transferred to the Trustee of the Mrs. Williams Management Trust.

WHEREAS, as part of the settlement of the administration of the Estate of Decedent and the Mrs. Williams Management Trust, and to affect a distribution to the residuary beneficiary under the Will and the Mrs. Williams Trust Instrument, both the Trustee of the Mrs. Williams Management Trust and the Personal Representative of the Estate hereby join in this deed to signify their consent to the transfer any interest held in either capacity to the transfer provided herein.

WHEREAS, Jackie Ray Williams has created that certain trust titled the Jackie Ray Williams Management Trust, dated the 20th day of May, 1999, as amended and restated (the "Mr. Williams Trust Instrument"), and desires to transfer any interest he may receive in the Property to the Trustee of said Trust.

WHEREAS, Jackie Ray Williams, as the successor Trustee of the Rosella M. Williams Management Trust, created pursuant to an instrument dated May 20, 1999, as most recently amended and restated pursuant to an instrument dated August 28, 2020, hereby certifies as follows with regard to the Mrs. Williams Trust Instrument:

- (1) The Rosella M. Williams Management Trust, executed the 20th day of May, 1999, as most recently amended and restated by an instrument dated the 28th day of August, 2020, currently exists.
- (2) The Settlor of the Mrs. Williams Trust Instrument is Rosella Marie Williams, deceased.
- (3) The undersigned is the currently acting Trustee of all Trusts created under the Mrs. Williams Trust Instrument.
- (4) The Trustee of the Mrs. Williams Management Trust has power to acquire, sell, convey, encumber, lease, borrow, manage and otherwise deal with interests in real and personal property in any of the Trust's name.
- (5) The Mrs. Williams Trust Instrument is irrevocable due to the death of the Decedent.
- (6) Title to trust property may be taken in the name of the Rosella M. Williams Management Trust, dated the 20th day of May, 1999.
- (7) The Mrs. Williams Trust Instrument has not been revoked, modified, or amended in any manner that would cause the representations contained herein to be incorrect.

WHEREAS, Jackie Ray Williams, as the Trustee of the Jackie Ray Williams Management Trust, created pursuant to an instrument dated May 20, 1999, as most recently amended and restated pursuant to an instrument dated August 28, 2020, hereby certifies as follows with regard to the Mr. Williams Trust Instrument:

- (1) The Jackie Ray Williams Management Trust, executed the 20th day of May, 1999, as most recently amended and restated by an instrument dated the 28th day of August, 2020, currently exists.
- (2) The Settlor of the Mr. Williams Trust Instrument is Jackie Ray Williams.

- (3) The undersigned is the currently acting Trustee of all Trusts created under the Mr. Williams Trust Instrument.
- (4) The Trustee has power to acquire, sell, convey, encumber, lease, borrow, manage and otherwise deal with interests in real and personal property in any of the Trust's name.
- (5) The Mr. Williams Trust Instrument is revocable.
- (6) Title to trust property may be taken in the name of the Jackie Ray Williams Management Trust, dated the 20th day of May, 1999.
- (7) The Mr. Williams Trust Instrument has not been revoked, modified, or amended in any manner that would cause the representations contained herein to be incorrect.

NOW, THEREFORE, KNOW ALL PERSONS BY THESE PRESENTS that for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) and other good and valuable consideration paid to the undersigned, **Jackie Ray Williams**, in his capacity as the successor Trustee of the Rosella M. Williams Management Trust, created pursuant to an instrument dated May 20, 1999, as most recently amended and restated pursuant to an instrument dated August 28, 2020, as the Personal Representative of the Estate of Rosella Marie Williams, deceased and in his individual capacity (collectively, the "GRANTOR"), the receipt and sufficiency of which is hereby acknowledged, does hereby GRANT, BARGAIN, SELL, CONVEY and ASSIGN, forever, unto **Jackie Ray Williams**, as the Trustee of the Jackie Ray Williams Management Trust dated the 20th day of May, 1999, as amended and restated (the "GRANTEE"), all right, title and interest in the following described real estate situated in Shelby County, Alabama, to-wit:

Parcel A:

The SE1/4 of the NE1/4 of the West half of the NE1/4 lying East of Waxahatchee Creek, and all that part of the East half of the NW1/4 lying East of Waxahatchee Creek; all that part of the East half of SE1/4 and all that part of the West half of the SE1/4 lying East of Waxahatchee Creek; all in Section 7, Township 24, Range 15 East.

Parcel B:

The West half of the SW1/4 and the NE1/4 of SW1/4, all in Section 8, Township 24, Range 15 East; LESS AND EXCEPT that portion of the herein described property which is located in the NE1/4 of the SW1/4 and the SW1/4 of the SW1/4 and lying East of the public road which services Porter's landing.

Parcel C:

All that part of the NW1/4 of the NW1/4 of Section 7, Township 24 North, Range 15 East which lies East of Waxahatchee Creek.

Parcel D:

NE1/4 of NE1/4, Section 7, Township 24 North, Range 15 East.

Parcel E:

SW1/4 of NW1/4 Section 8, Township 24 North, Range 15 East.

LESS AND EXCEPT:

W1/2 SW1/4 LYING W OF RD TH PT NE1/4 SW1/4 LYING W OF RD, all in Section 8, Township 24, Range 15 East; LESS AND EXCEPT that portion of the herein described property which is located in the NE1/4 of the SW1/4 and the SW1/4 of the SW1/4 and lying East of the public road which services Porter's landing.

And together with all and singular the improvements thereon, fixtures, rights, easements, restrictions, privileges, tenements and appurtenances thereunto belonging or in anywise appertaining.

This conveyance is expressly subject to any easements, restrictions or reservations of record, to any mineral rights outstanding and to ad valorem taxes for the current year.


This instrument is intended to convey to the GRANTEE the entire interests of the Trustee of the Rosella M. Williams Management Trust, created pursuant to an instrument dated May 20, 1999, as most recently amended and restated pursuant to an instrument dated August 28, 2020, the Decedent, the Estate of Rosella Marie Williams, deceased, and Jackie Ray Williams, individually, in and to the Property, and any leases or similar arrangements regarding the Property, to the GRANTEE.

This instrument is executed without warranty or representation of any kind on the part of the undersigned, express or implied, except that there are no liens or encumbrances outstanding against the Property conveyed that were created by the undersigned and not specifically excepted herein.

TO HAVE AND TO HOLD the Property unto GRANTEE in fee simple forever.
