KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 9th day of June, 2010, ERIC NORTON AND KATSUFUSA AZUMA, BOTH UNMARRIED executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC. 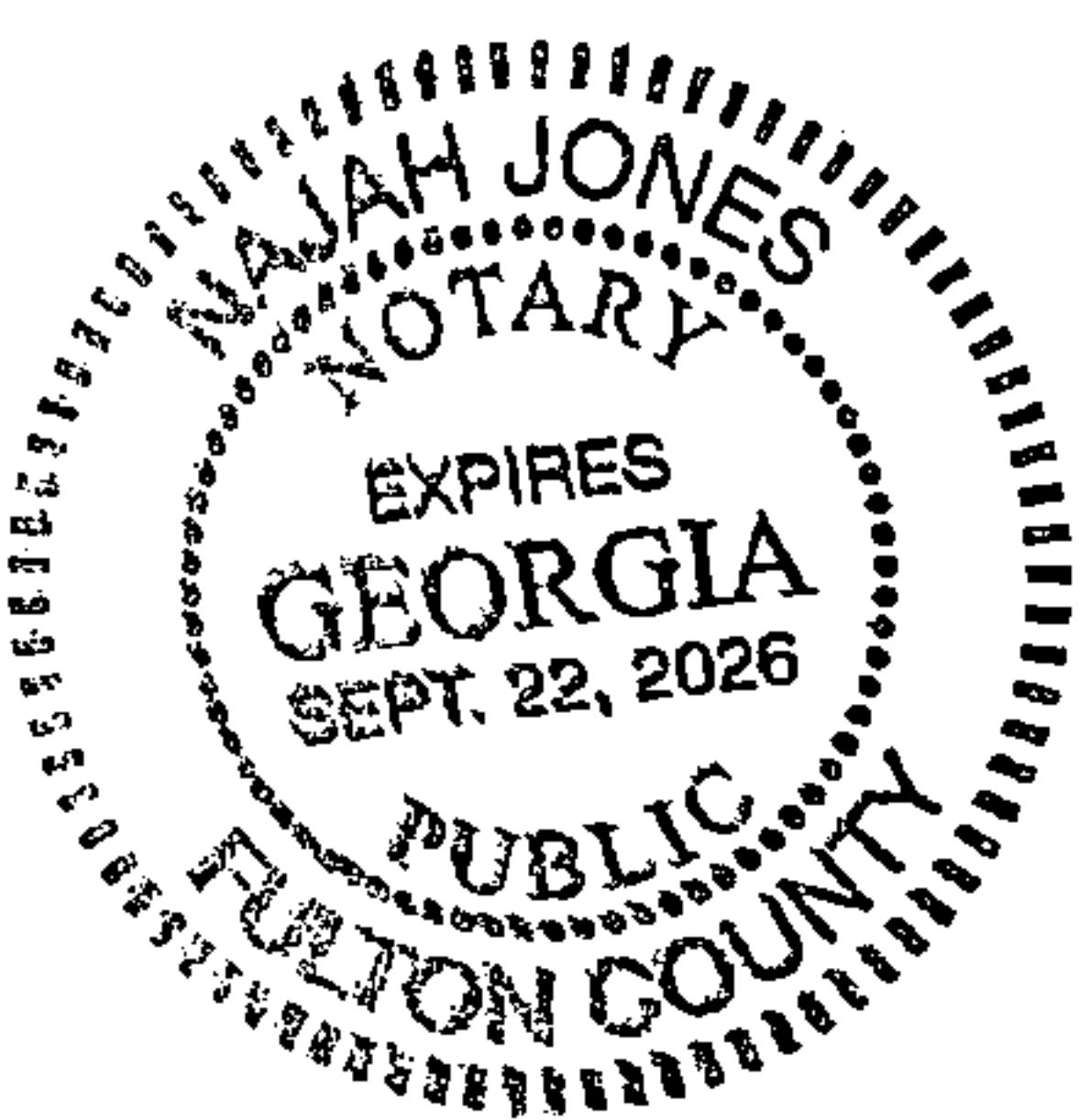
