Certification of Trust for the

The undersigned, **JOSEPH MARTINEZ** and **CHELSEY MARTINEZ**, being first duly sworn, depose and say, they are at least 19 years of age and are the currently acting trustees of the **MARTINEZ LIVING TRUST** dated **September 17, 2024**, and further states as follows:

1. There is a valid and existing trust, having been created by the **MARTINEZ LIVING TRUST** dated **September 17, 2024**.

 - A. The original settlor(s) and successor settlor(s), if any, of the trust are: **JOSEPH MARTINEZ** and **CHELSEY MARTINEZ**.
 - B. The following person(s) contributed money, funds, real property, or personal property to the trust:
JOSEPH MARTINEZ and **CHELSEY MARTINEZ**
 - C. The original settlor(s), **JOSEPH MARTINEZ** and **CHELSEY MARTINEZ**, are alive and well.
 - D. The original trustees are **JOSEPH MARTINEZ** and **CHELSEY MARTINEZ**
 - E. The name and address of the currently acting trustees:

 - F. The **MARTINEZ LIVING TRUST** dated **September 17, 2024** has definite beneficiaries. The named beneficiaries are not the sole trustee and sole beneficiary.
 - G. The tax identification number of the trust is the Social Security number of either Joseph Martinez or Chelsey Martinez and is intentionally omitted for privacy reasons.
 - H. If either **JOSEPH MARTINEZ** or **CHELSEY MARTINEZ** are no longer serving as a Co-Trustee, the non-incapacitated or surviving spouse will serve as sole Trustee. If he or she is unable to serve or to continue to serve for any reason, then the following will serve as successor Trustee, in in order named:

3. Trust Assets held in the Trust should be titled as follows: **JOSEPH MARTINEZ and CHELSEY MARTINEZ, Trustees, of the MARTINEZ LIVING TRUST** dated **September 17, 2024**.

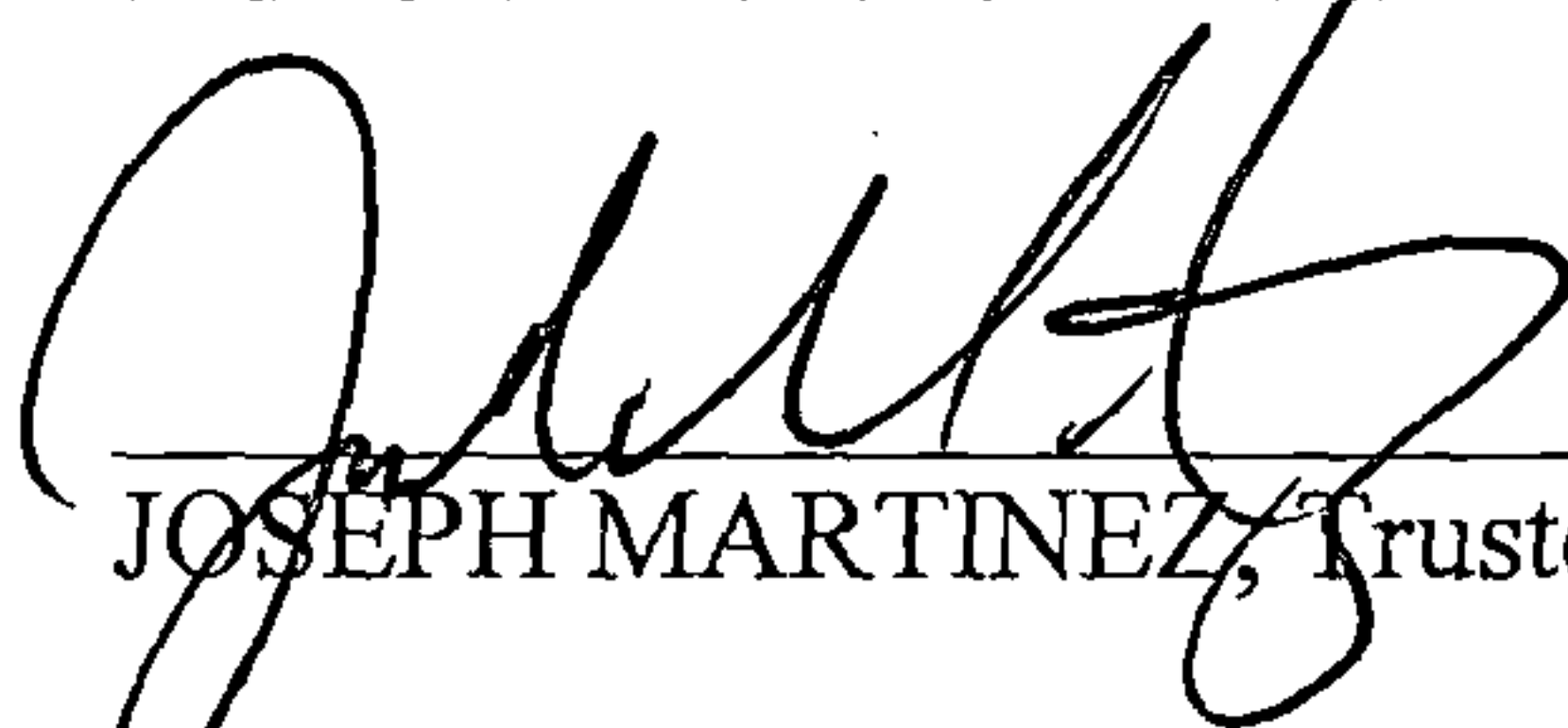
4. An alternate description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.

5. No person or entity paying money to or delivering property to our Trustees shall be required to see its application. All persons relying on this document regarding our Trustees and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A Copy of this Certificate of Trust shall be just as valid as the original.

6. The terms of the Trust provide that a third party may rely upon this Certification of Trust as evidence of the Trust and is specifically relieved of any obligation to inquire into the terms of this Trust or the authority of my Trustee, or to see the application that my Trustee makes of funds or other property received by my Trustee.

7. The Trust is revocable. **JOSEPH MARTINEZ** and **CHELSEY MARTINEZ** hold the power to revoke the Trust, acting jointly and not separately. Our Trust, executed on September 17, 2024, currently exists, has not been revoked, modified, or amended in any manner that would cause the representations contained in this certification of trust to be incorrect. There have been no amendments limiting the powers of our Trustees over trust property. A Copy of this Certificate of Trust shall be just as valid as the original.

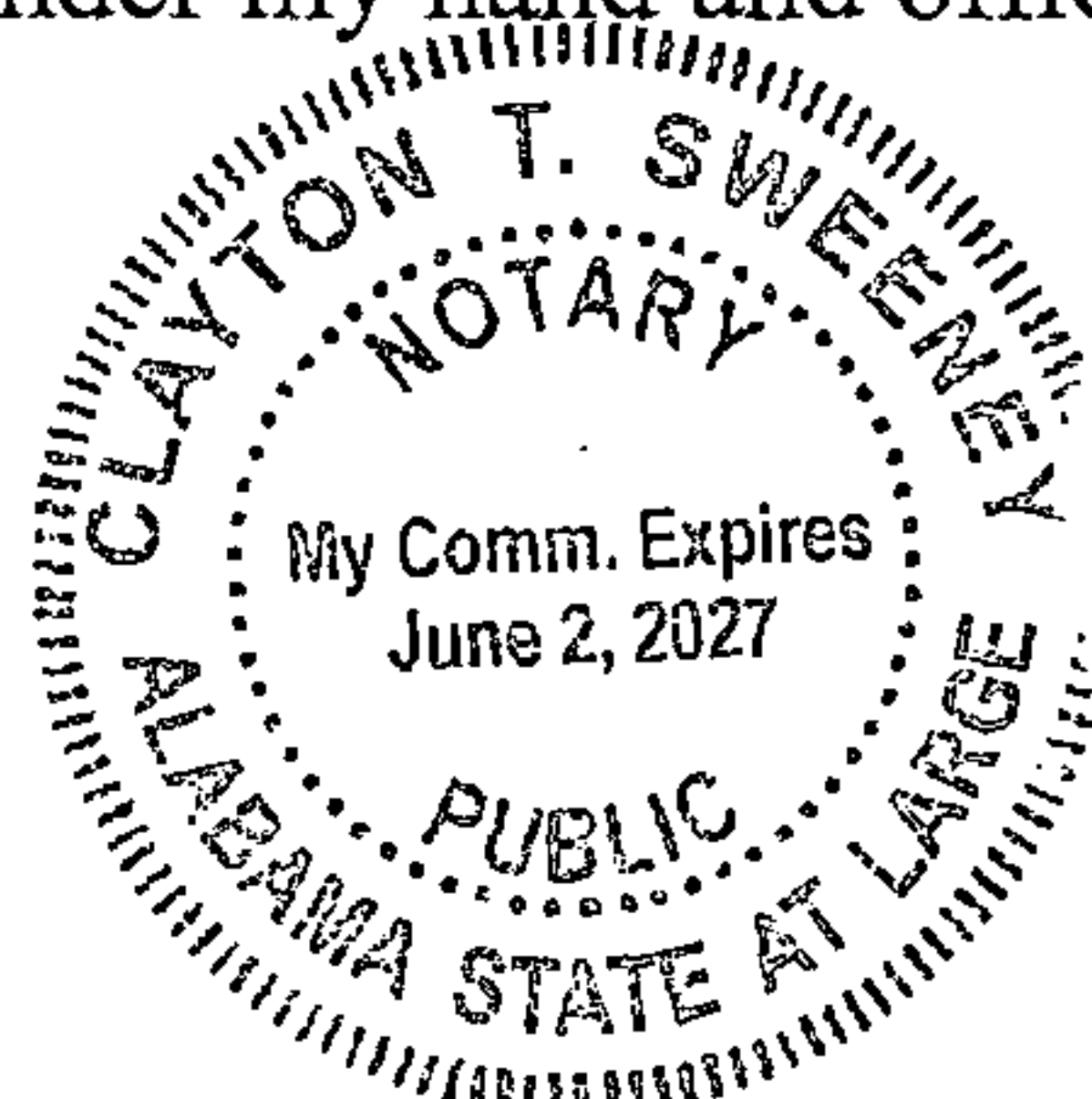

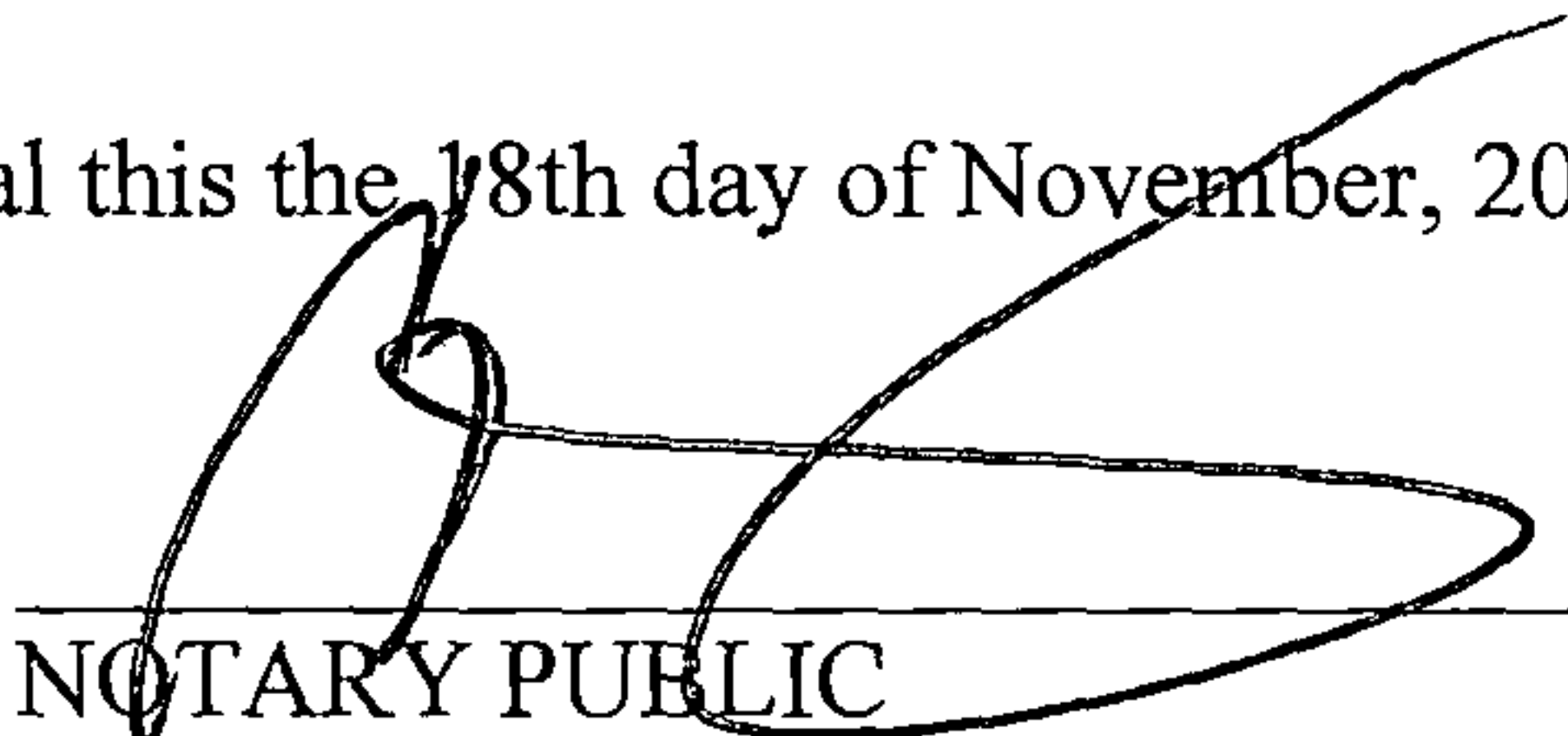
