KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **Two Hundred Sixty-Four Thousand and no/100 Dollars (\$264,000.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **Jackie Batson, an unmarried woman**, (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **Olivia Clarice Lewis and Corbin Bentley**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

Lot 228, according to the survey of The Reserve at Timberline Phase 3, as recorded in Map Book 38, Page 53, in the Office of the Judge of Probate of Shelby County, Alabama.

\$259,218.00 of the purchase price recited herein was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.

Jackie Batson is one and the same person as Jacci Batson.


SUBJECT TO:






