

## WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

STATE OF ALABAMA)

KNOW ALL MEN BY THESE PRESENTS, That in consideration of **TEN THOUSAND DOLLARS AND NO CENTS (\$10,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, we, *Della M. Pender, a married woman* (herein referred to as *Grantors*) grant, bargain, sell and convey unto *Mary Gates Childers and Jason Ryan Childers, as joint tenants with right of survivorship* (herein referred to as *Grantees*), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

One lot starting at the southwest corner of J. F. McGraw's lot, formerly owned by T. W. Morefield and now owned by J. C. Gates, and running South 35 yards; thence East 140 yards; thence North 35 yards to the southeast corner of J. F. McGraw's lot; thence West along the line of J. F. McGraw's lot 140 to starting point, the above described land being and lying in Section 14, Township 19, Range 2 East, in Shelby County, Alabama, in the Town of Vincent, and being about equally divided, one-half in NE ¼ of NW ¼ and one-half in NW ¼ of NW ¼.

**SUBJECT TO:**

1. Ad valorem taxes due and payable October 1, 2025.
2. Easements, restrictions, rights of way, and permits of record

**TO HAVE AND TO HOLD** Unto the said GRANTEES as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I (we) do for myself (ourselves) and for my (our) heirs, executors, and administrators covenant with the said Grantees, their heirs and assigns, and I am (we are) lawfully seized in fee simple of said premises, that they are free from all encumbrances unless otherwise noted above, that I (we) have a good right to sell and convey the same as aforesaid, that I (we) will, and my (our) heirs, executors and administrators shall, warrant and defend the same to the said Grantees, heirs, executors and assigns forever, against the lawful claims of all persons.


