 - (v) Regions' (or its successors' and assigns') occupancy costs of the North Tower and/or North Tower Parcel, including any assessments which may become due for the North Tower Parcel under the Approved Master Covenants unless any such assessments apply solely to the North Parcel.
- 3. <u>Full Force and Effect</u>. Except as otherwise modified and amended herein, all the terms and provisions of the Agreement shall remain in full force and effect.
- 4. <u>Counterparts</u>. This Amendment may be executed in two or more separate counterparts, each of which, when so executed and delivered, shall constitute an original, and such counterparts shall together constitute one and the same instrument.
