MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 31st day of October, 2007, MARY A KELLY, AN UNMARRIED WOMAN executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC. AS MORTGAGEE, AS NOMINEE FOR NEW SOUTH FEDERAL SAVINGS BANK, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on November 15, 2007, at Instrument Number 20071115000523690, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **LEGACY MORTGAGE ASSET TRUST 2021-GS2**, by instrument number 20220524000208970, recorded in the aforesaid Probate Office ("Transferee"); and

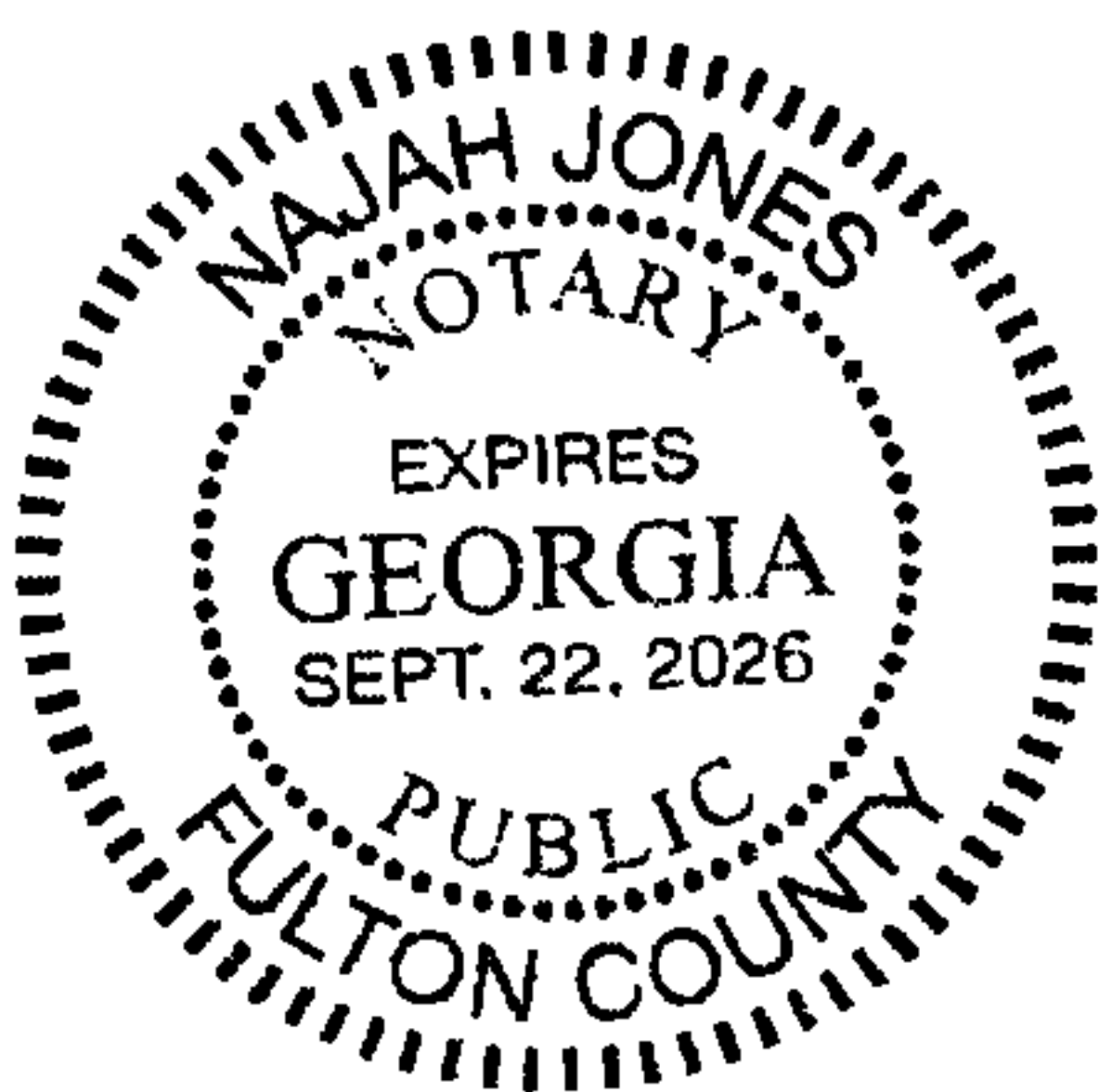
