That in consideration of **THREE HUNDRED SIXTY THOUSAND AND 00/100 Dollars (\$360,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

(hereinafter referred to as “Grantors”) do grant, bargain, sell and convey unto

**Jacob Lee and Nancy Lee**

(hereinafter referred to as “Grantees”), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

**Lot 6, according to the Map of Buckhorn Valley Estates, a Private Gated Subdivision, originally recorded in Map Book 53, Pages 67 A, B, and C, as amended and corrected by Final Plat recorded in Map Book 53, Pages 87 A, B, and C, in the Probate Office of Shelby County, Alabama**

  - (3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.


