
Part of the West half of Section 36, Township 18 South, Range 2 West, Shelby County, Alabama, and being more particularly described as follows:

Site-4 and Building 22, 682.41 feet; thence North 01 degrees 36 minutes 01 seconds East 166.08 feet to a point on said North line of the South half of the Southeast quarter of the Northwest quarter of Section 36; thence South 88 degrees 24 minutes 25 seconds East along said same 52.95 feet to the Point of Beginning.

## Building 22, 22 Inverness Center Parkway, Hoover, Alabama 35242.

In the aforesaid civil action, Plaintiff alleges the following:

- 1. Defendant, Hertz Investment Group, LLC, owns the property described above.
- 2. Pursuant to its contract with Defendant, Hertz Investment Group, LLC, Plaintiff, Vulcan Mechanical Services, Inc., performed work, labor, and materials on the property located at Building 22, 22 Inverness Center Parkway, Hoover, Alabama 35242 totaling the amount of \$178,238.01.
- 3. Vulcan Mechanical Services, Inc.'s work, labor, and materials included inspecting and repairing an industrial chiller unit along with renting a temporary chiller during the time the repairs were being made.
- 4. The indebtedness remained unpaid when the entirety of the indebtedness matured on July 18, 2024. Therefore, Plaintiff, Vulcan Mechanical Services, Inc., filed a mechanics and materialmen's lien (20240703000202880) claiming separately and severally, as to the land, buildings and improvements located at Building 22, 22 Inverness Center Parkway, Hoover, Alabama 35242.
- 5. The amount of \$178,238.01 is due and unpaid to Vulcan Mechanical Services, Inc. along with attorney's fees and costs of court pursuant to its contract with Hertz Investment Group, LLC.
