KNOW ALL MEN BY THESE PRESENTS, that in consideration of the sum of **Forty Thousand and 00/100 (\$40,000.00)** and other valuable considerations to the undersigned GRANTOR(S), **DAVID H. COOPER**, a married man, (hereinafter referred to as GRANTORS), in hand paid by the GRANTEE(S) herein, the receipt of which is hereby acknowledged, the said GRANTOR(S) does by these presents GRANT, BARGAIN, SELL and CONVEY unto **ALLEN R. SHELLEY and SUSAN S. SHELLEY**, hereinafter referred to as GRANTEE(S), for and during their joint lives and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described real estate, situated in County of Shelby State of Alabama, to-wit:

ALL THAT PART OF THE SW 1/4 OF THE NW 1/4, SECTION 10, TOWNSHIP 18, RANGE 1 EAST, LYING SOUTH OF HIGHWAY 25, SITUATED IN SHELBY COUNTY, ALABAMA.

THE SUBJECT PROPERTY IS NOT THE HOMESTEAD OF THE GRANTOR OR HIS SPOUSE.




