KNOW ALL MEN BY THESE PRESENTS, That in consideration **ONE THOUSAND AND NO/100 DOLLARS (\$1,000.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, ***Billy Raye Moore and wife, Syble Moore*** (herein referred to as ***Grantor***) grant, bargain, sell and convey unto ***Christopher Barber and Shelley Barber, as joint tenants with right of survivorship*** (herein referred to as ***Grantees***), the following described real estate, situated in: **SHELBY** County, Alabama, to-wit:

Lots 24, 25, 26, and 27 in Block 2, Cottage Hill Subdivision of Vincent, Alabama; in Section 15, Township 19, Range 2 East, in Shelby County, Alabama.

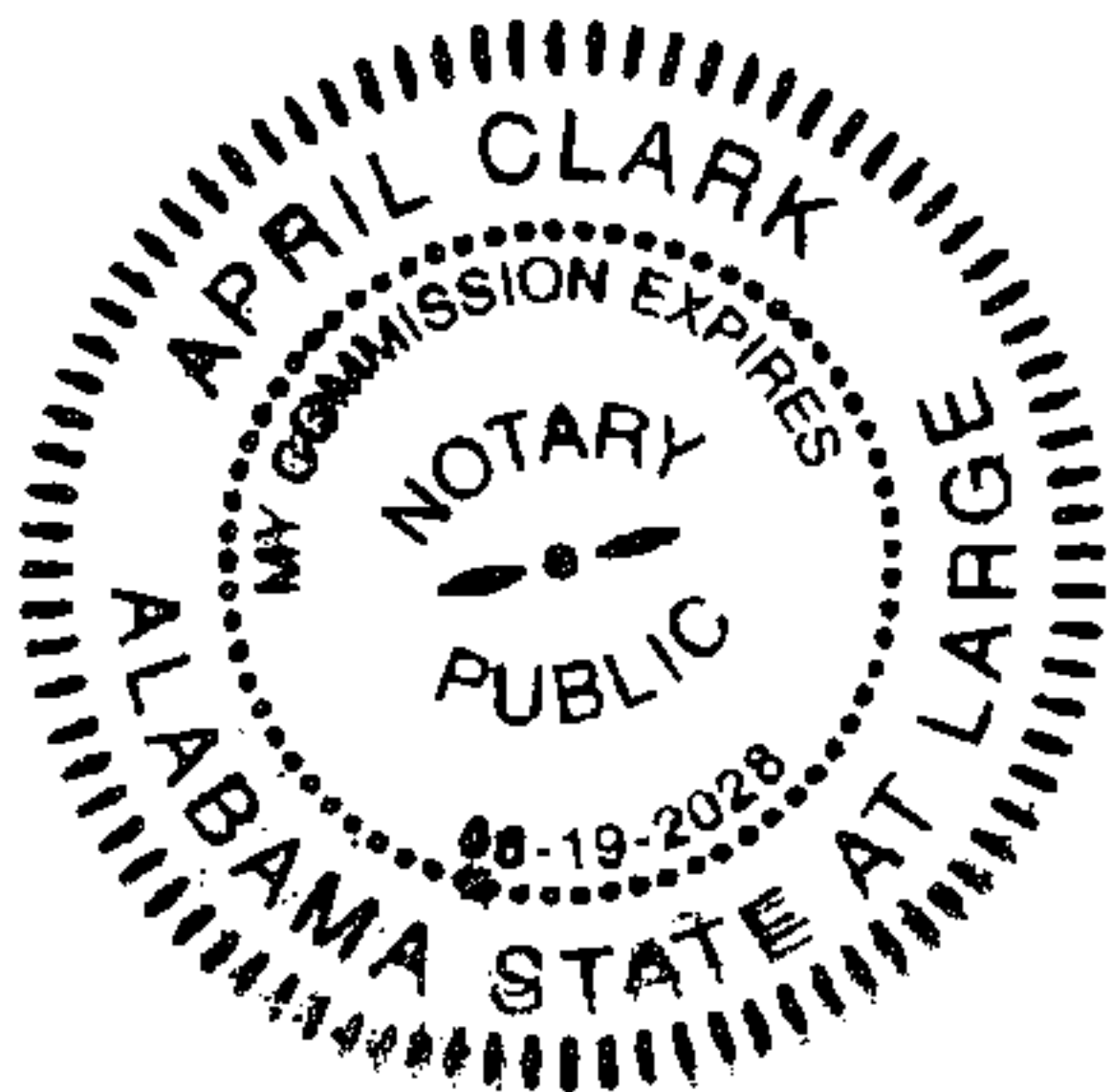
