WHEREAS that certain Declaration of Covenants, Conditions and Restrictions for Stonebriar Phase 2 Property Owners Association, Inc. 

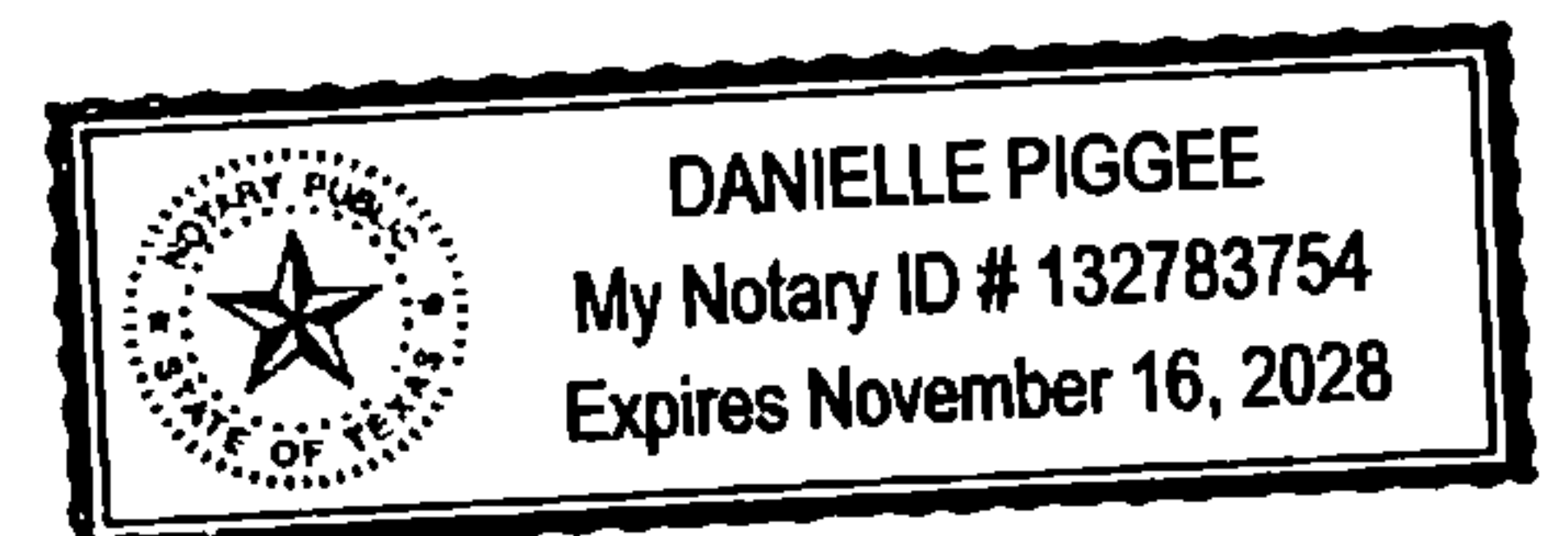
