Evans and Donita Evans, husband and wife** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS hereby give, grant, bargain, sell and convey unto the GRANTEES, **Bobby Lucas and Hannah Lucas** (hereinafter referred to as GRANTEES), their successors and assigns, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Subject to existing easements, current taxes, restrictions, set-back lines and rights of way, if any, of record.

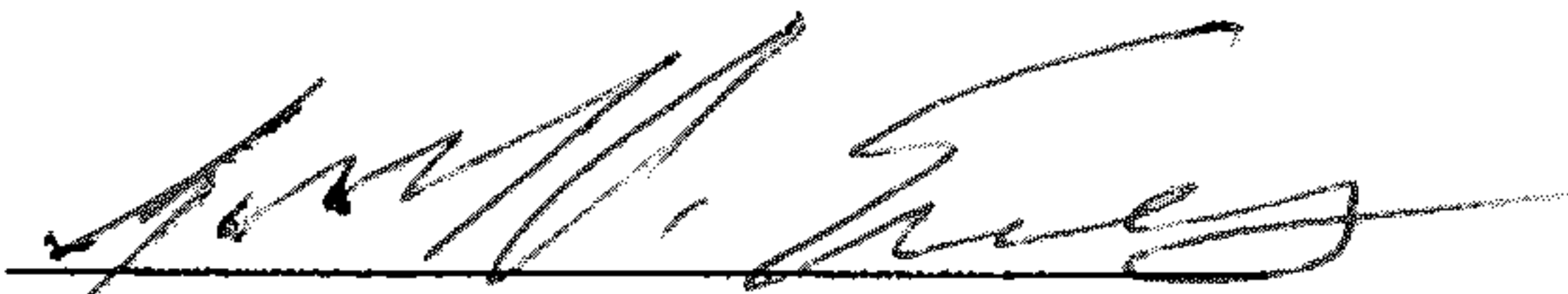

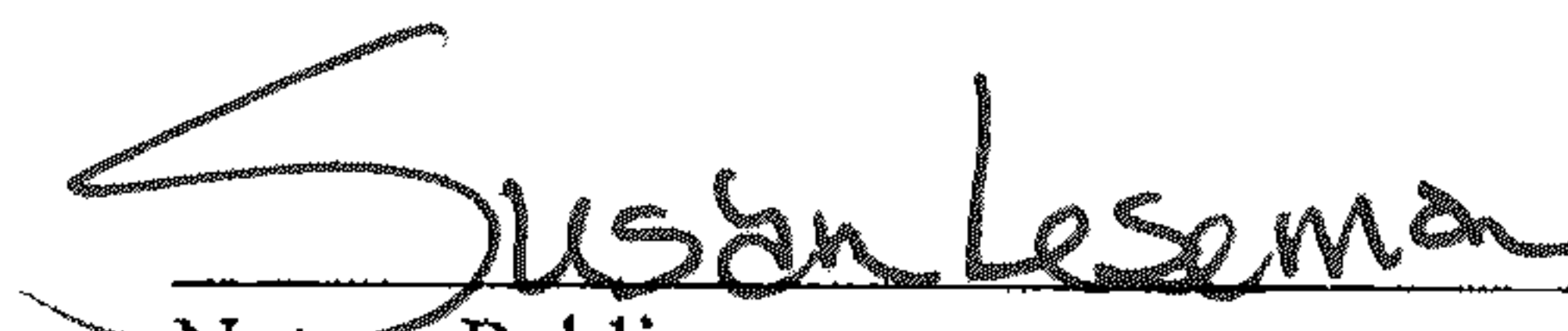

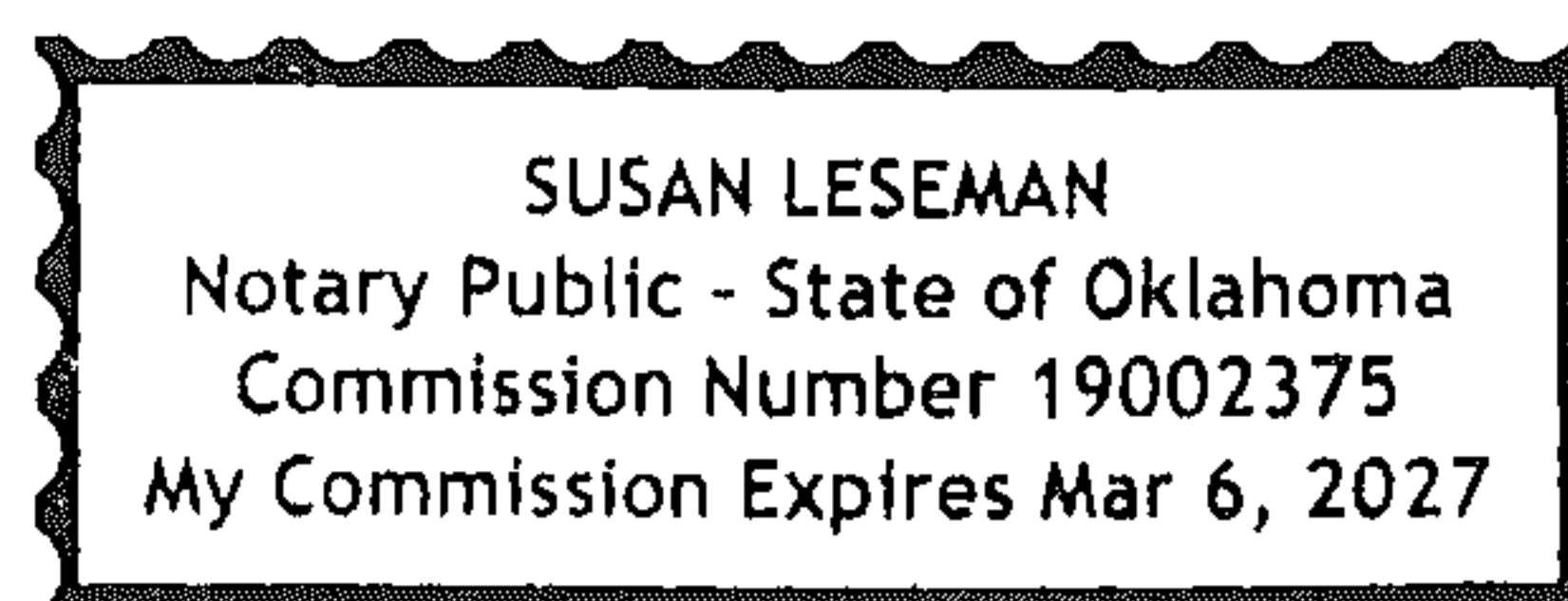
