**GENERAL WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of **TWO HUNDRED SEVENTY THOUSAND AND 00/100 DOLLARS (\$270,000.00)**, and other good and valuable consideration in hand paid to Nathaniel Stanley, III, Administrator of Estate of Augustine Stanley, Shelby County Probate Case No. PR-2024-000288 (hereinafter referred to as "Grantor"), the receipt and sufficiency of which is hereby acknowledged, by the Sonja Farrington and Ina Farrington, as joint tenants with right of survivorship (hereinafter referred to as "Grantees"), hereby grant, bargain, sell and convey unto Grantees, in fee simple absolute together with every contingent remainder and right of reversion, and subject to all the provisions contained in this warranty deed, the following described real property situated in Shelby County, Alabama, to-wit:

**\$234,025.00** of the above-recited purchase price was paid from a mortgage loan closed simultaneously herein.



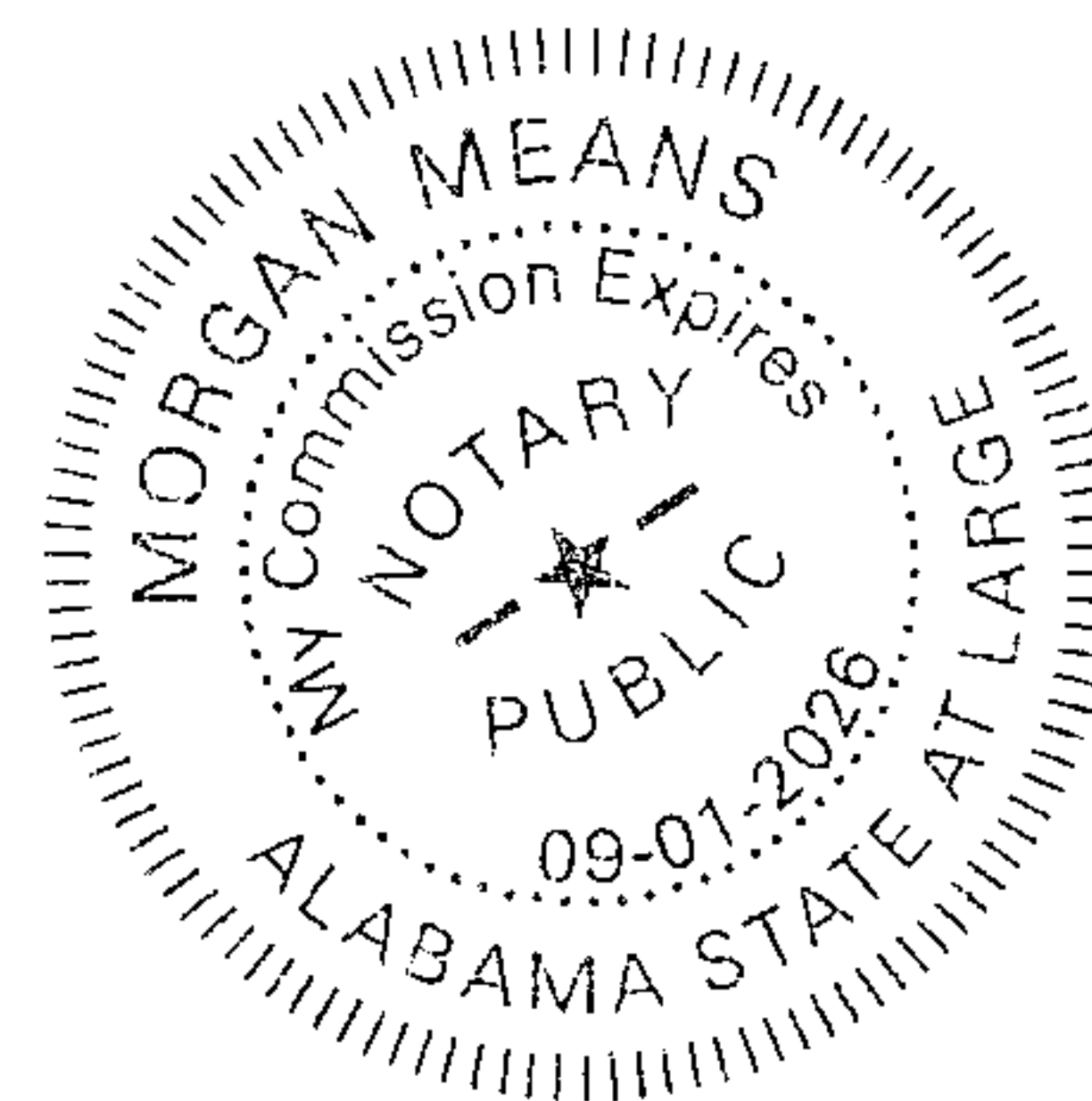

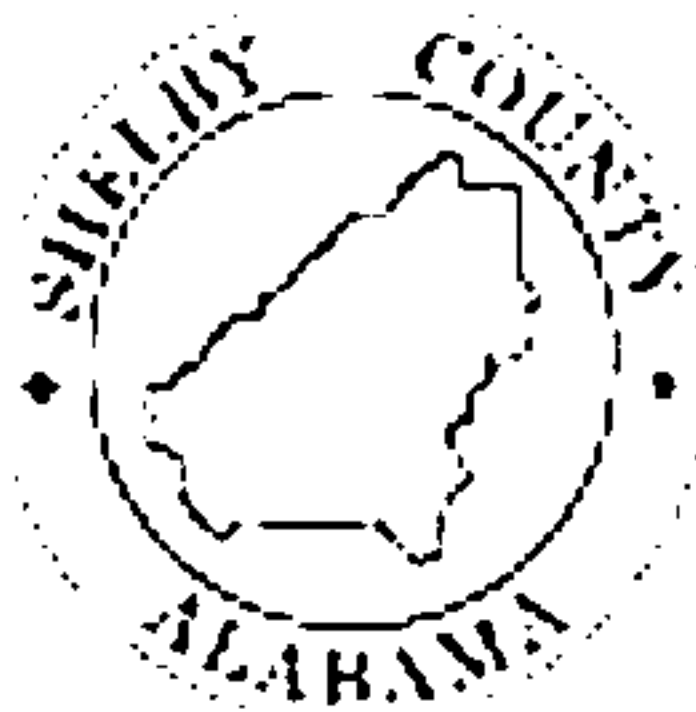
