WARRANTY DEED**

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of FOUR HUNDRED EIGHTY-NINE THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$489,900.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantor, **CONNERY K. DAVIS, an unmarried person** (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **JUWAN M. MURPHY and D'ALEXANDRIA MURPHY** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 128, according to the Final Plat of Grey Oaks Sector I, as recorded in Map Book 38, Page 148, in the Probate Office of Shelby County, Alabama.
