Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, mineral/mining rights, and declarations of record, if any.

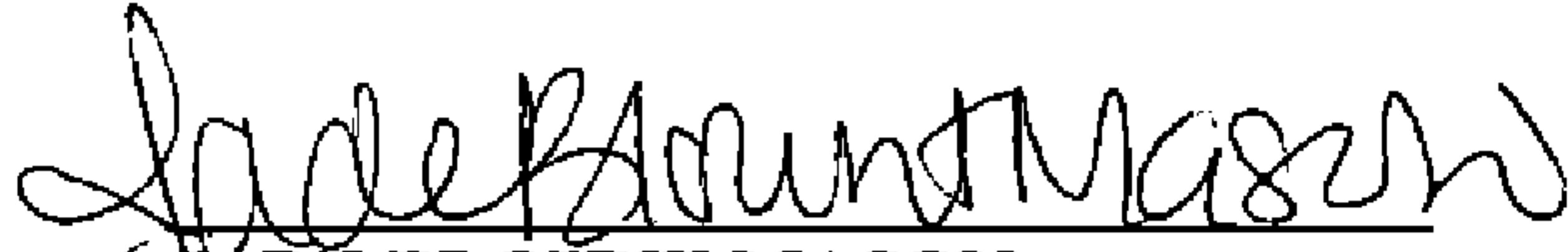
\$55,000.00 of the above-recited consideration is being paid in cash.

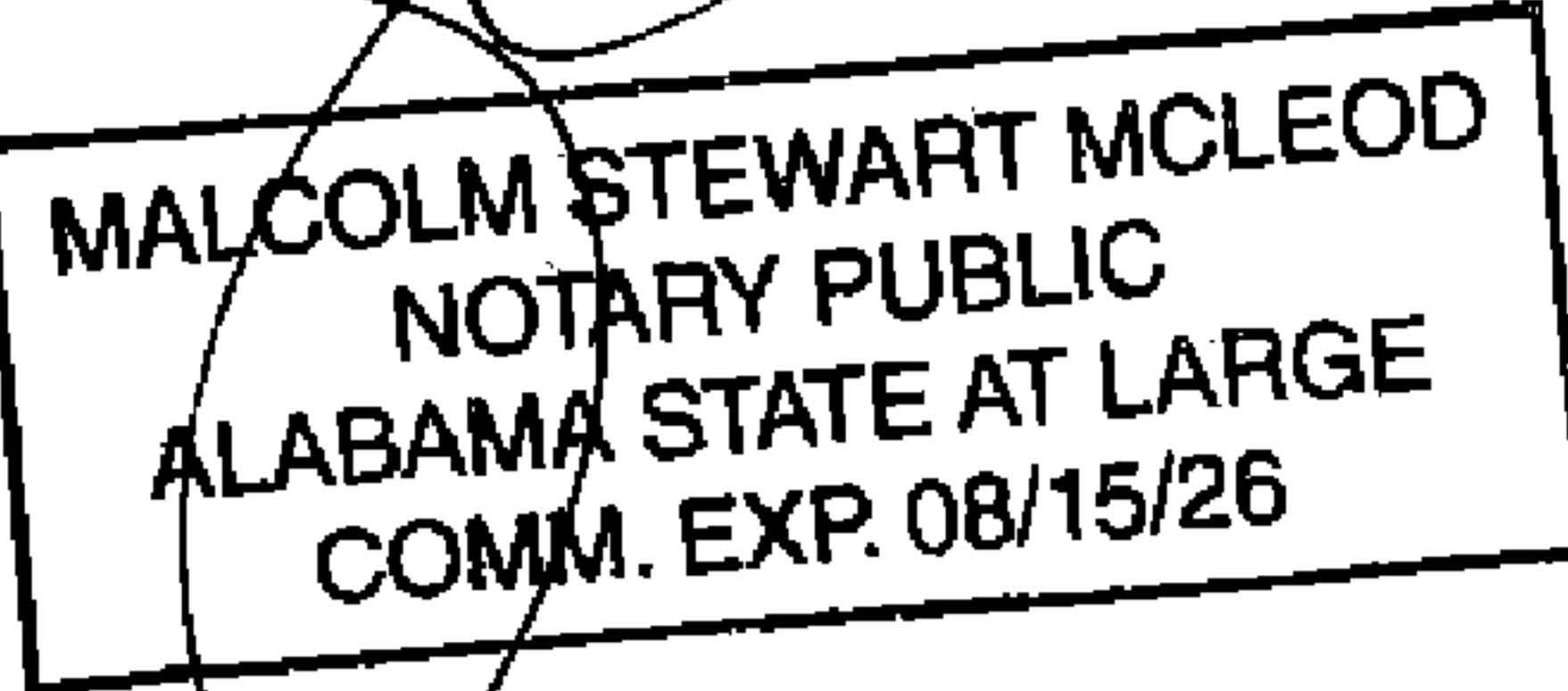
