Know All Men by These Presents: That in consideration of **Two Hundred Ninety-Nine Thousand Nine Hundred and 00/100 Dollars (\$299,900.00)**, to the undersigned Grantor, in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, I, **HANNAH SANDERS, a married person** (herein referred to as Grantor), grant, bargain, sell and convey unto **JONATHAN BROOKS FREEMAN and SARAH KALLAHER FREEMAN** (herein referred to as Grantees), the following described real estate, situated in **SHELBY** County, Alabama, to-wit:

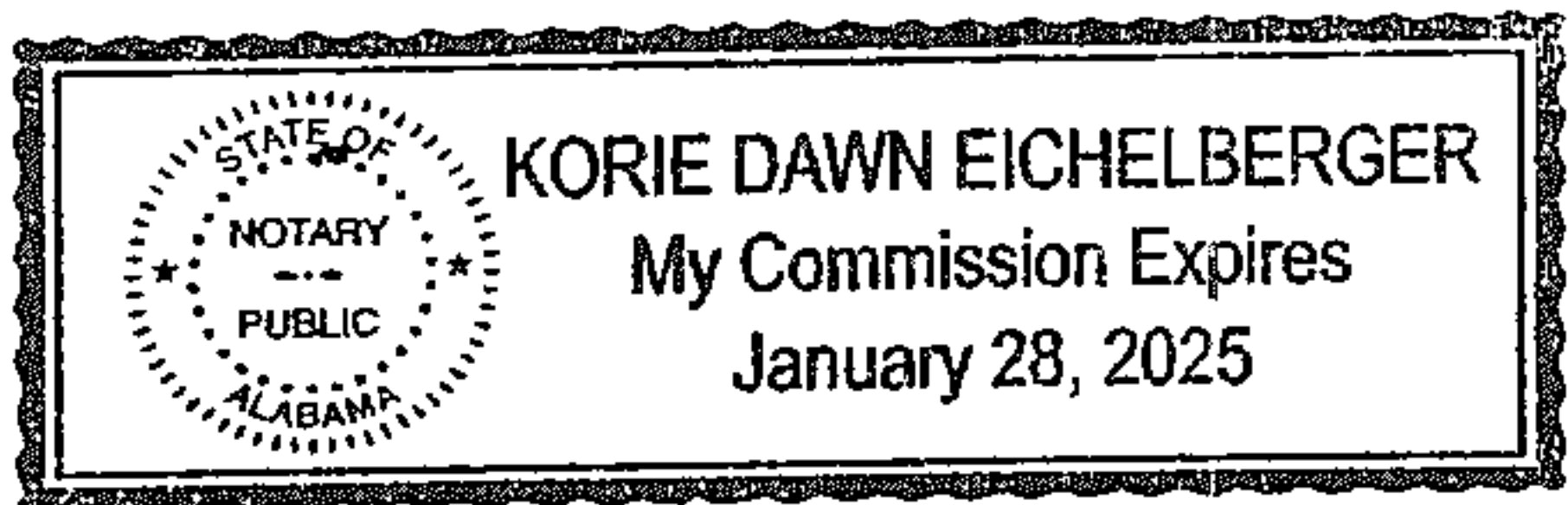
