

**CERTIFICATION OF TRUST

5. The Trust is revocable by the Settlers.

The Trust may take title to assets by any descriptive name including, but not limited to: The Bullard Family Trust, The Bullard Family Trust, or the Bullard Family Revocable Trust dated August 2, 2023, or The Bullard Family Trust u/d/t August 2, 2023, or The Bullard Family Trust u/a dated August 2, 2023 where "u/d/t" stands for "Under Declaration of Trust" and "u/a" stands for "Under Agreement," with or without specifying the date of the Trust, any change in Trustee, or any amendment to the trust instrument.

Any person or entity may rely upon this Certification of Trust as evidence of the existence of said trust, and in doing so is relieved of any obligation to verify that any transaction entered into by a trustee or successor trustee thereunder is consistent with the terms and conditions of the Trust Agreement.

By signing below, the Trustee hereby certifies that the Trust has not been modified or amended in any manner that would cause the representations contained in this Certification of Trust to be incorrect.



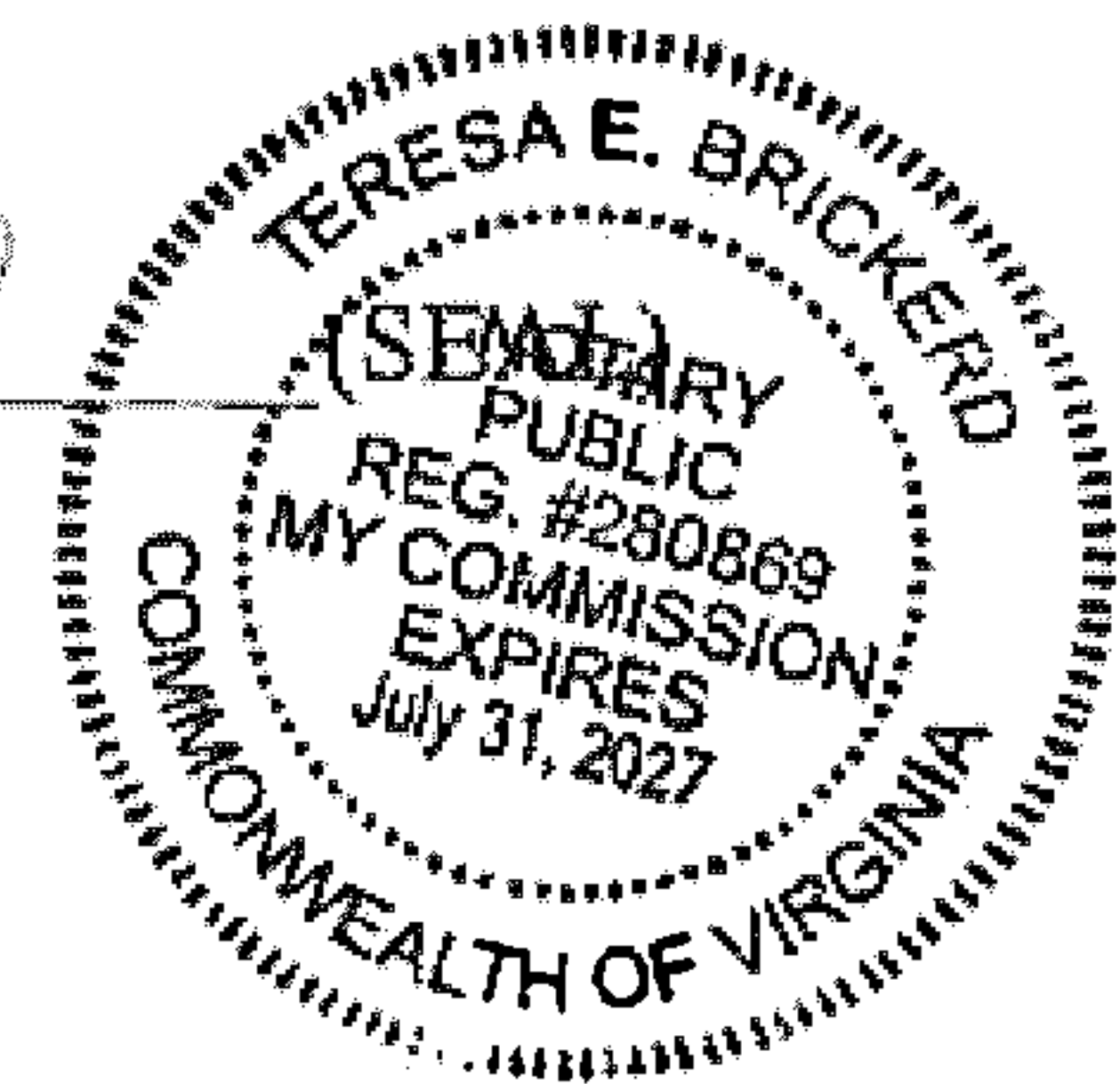
