KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Six Hundred Eighty-Five Thousand And No/100 Dollars (\$685,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Samantha McCluney and Michael McCluney, a married couple (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Barrett Cruz Blanton and Brenda Blanton (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 1-57, according to the Map and Survey of Chelsea Park, 1st Sector, Phase I & II, as recorded in Map Book 34, Page 21 A & B, in the Office of the Judge of Probate of Shelby County, Alabama.


Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.


Subject to a third party mortgage in the amount of \$635,000.00 executed and recorded simultaneously herewith.






