

POWER OF ATTORNEY DELEGATION OF POWERS BY PARENTS

(In Accordance with 26-2A-7, Code of Alabama 1975)

WE, Rosa Anastacia Vazquez Gonzalez and Ivan Diaz Puga, the legal and natural mother and the legal and natural father, respectively, of the following four minor children:

- (1) Fatima Nicol Diaz Vazquez, born on August 21, 2013, within the State of California;
- (2) Ivanna Yoleth Diaz Vazquez, born on September 13, 2017, within the State of Alabama;
- (3) Aitana Daleth Diaz Vazquez, born on January 19, 2022, within the State of Alabama; and
- (4) Bruno Diaz Vazquez, born on March 2, 2023, within the State of Alabama,

HEREBY designate CANDY HERNANDEZ GONZALEZ as our proxy for making healthcare, support, education, and maintenance decisions. We hereby temporarily delegate our powers as parents to Candy Hernandez Gonzalez for the duration of one (1) year.

This shall include but not be limited to emergency room services, pediatrician services, ophthalmologic services, hospitalization, pharmacy services, and the like. In the event that the children's Medicaid health insurance needs to be renewed, Candy Hernandez Gonzalez is authorized to take all steps necessary to ensure the children remain covered by the Alabama Medicaid Program.

Candy Hernandez Gonzalez shall have decision making authority for any and all education related needs of our children. This means that she will be able to enroll our children in any school of her choosing and may designate alternative third persons at the children's schools, to aid in pick up and drop off. If any parent/teacher conferences are to occur, Candy Hernandez Gonzalez shall be permitted to participate and receive any and all confidential information related to the children.

Candy Hernandez Gonzalez is hereby authorized to enroll the children in any and all extracurricular activities as she sees fit. The children are allowed to participate in any activity that Candy Hernandez Gonzalez consents to.


