That in consideration of the sum of **One Hundred Twenty Nine Thousand Dollars and No Cents (\$129,000.00), the amount of which can be verified in the Sales Contract between the parties hereto**, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Dianne Moore**, a single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Kara Patton and Antony Graham Patton, as joint tenants with right of survivorship** (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 5, according to the survey of Quail Estates, as recorded in Map Book 26, Page 73, in the Probate Office of Shelby County, Alabama.

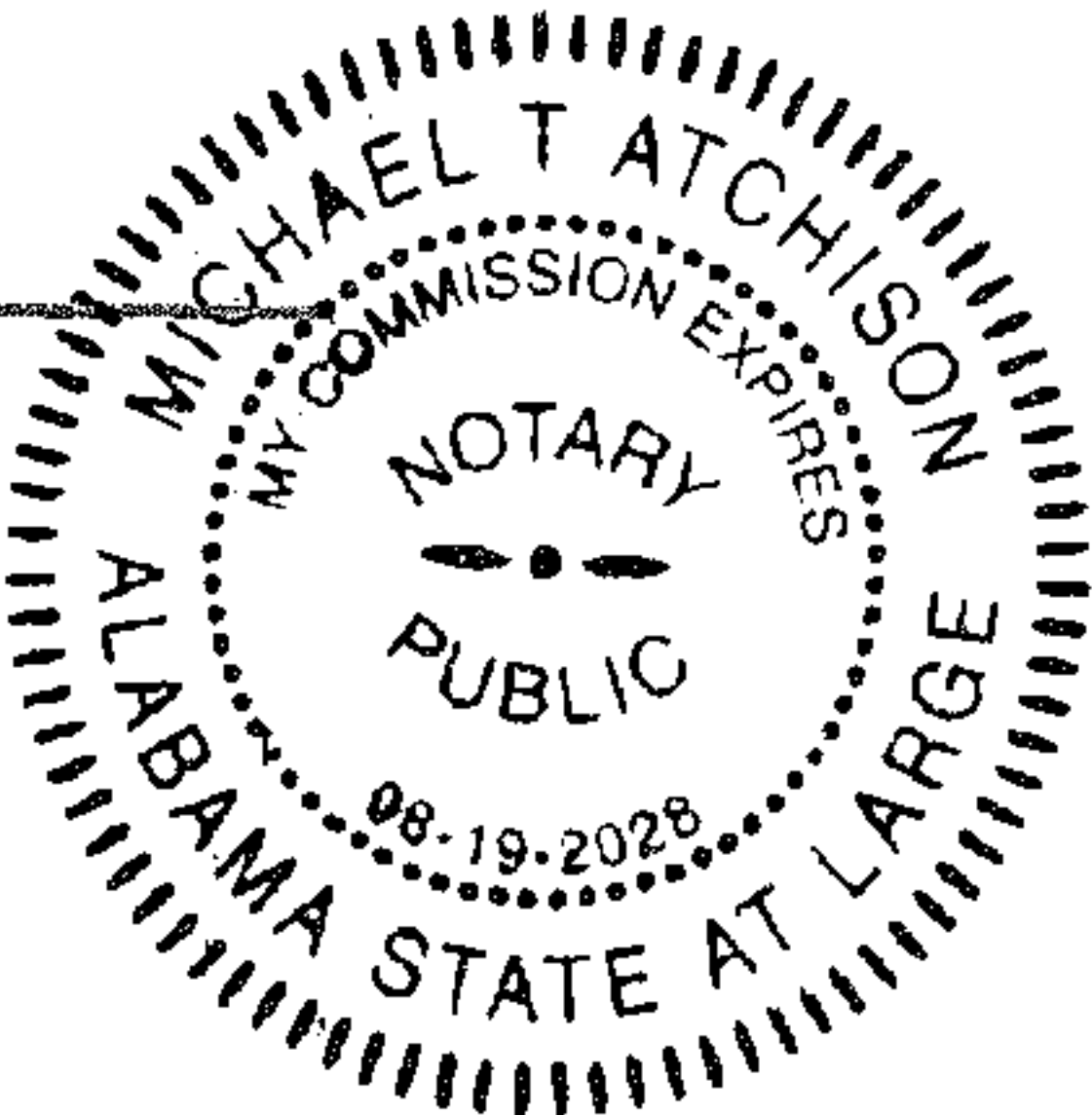

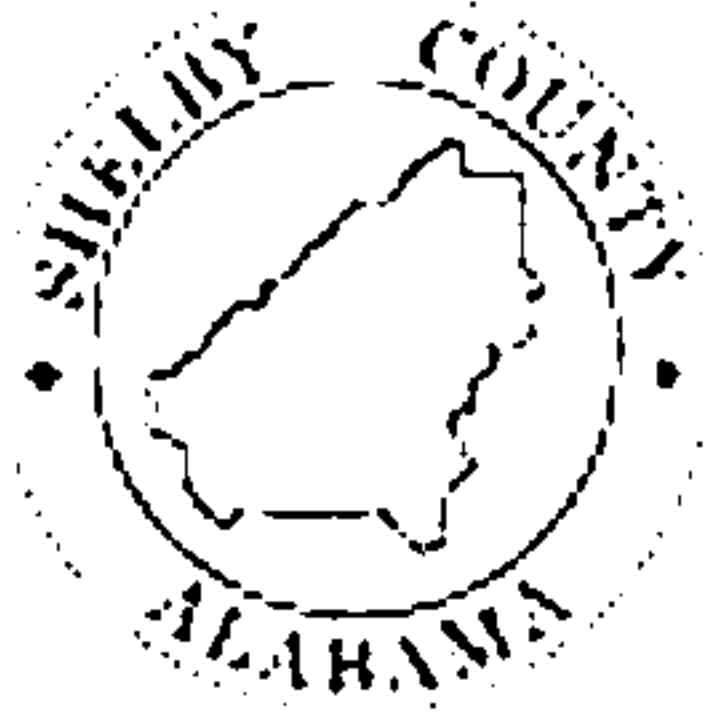
