JOINTLY FOR LIFE WITH REMAINDER TO SURVIVOR

} Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Three Hundred Five Thousand Dollars and No Cents (\$305,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Cecilia Barrios Millan**, a single woman (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Kiwauna Presley and Steven Presley**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 197, according to the Final Plat of Camden Cove West, Sector 1, as recorded in Map Book 33, Page 143, in the Office of the Judge of Probate of Shelby County, Alabama.

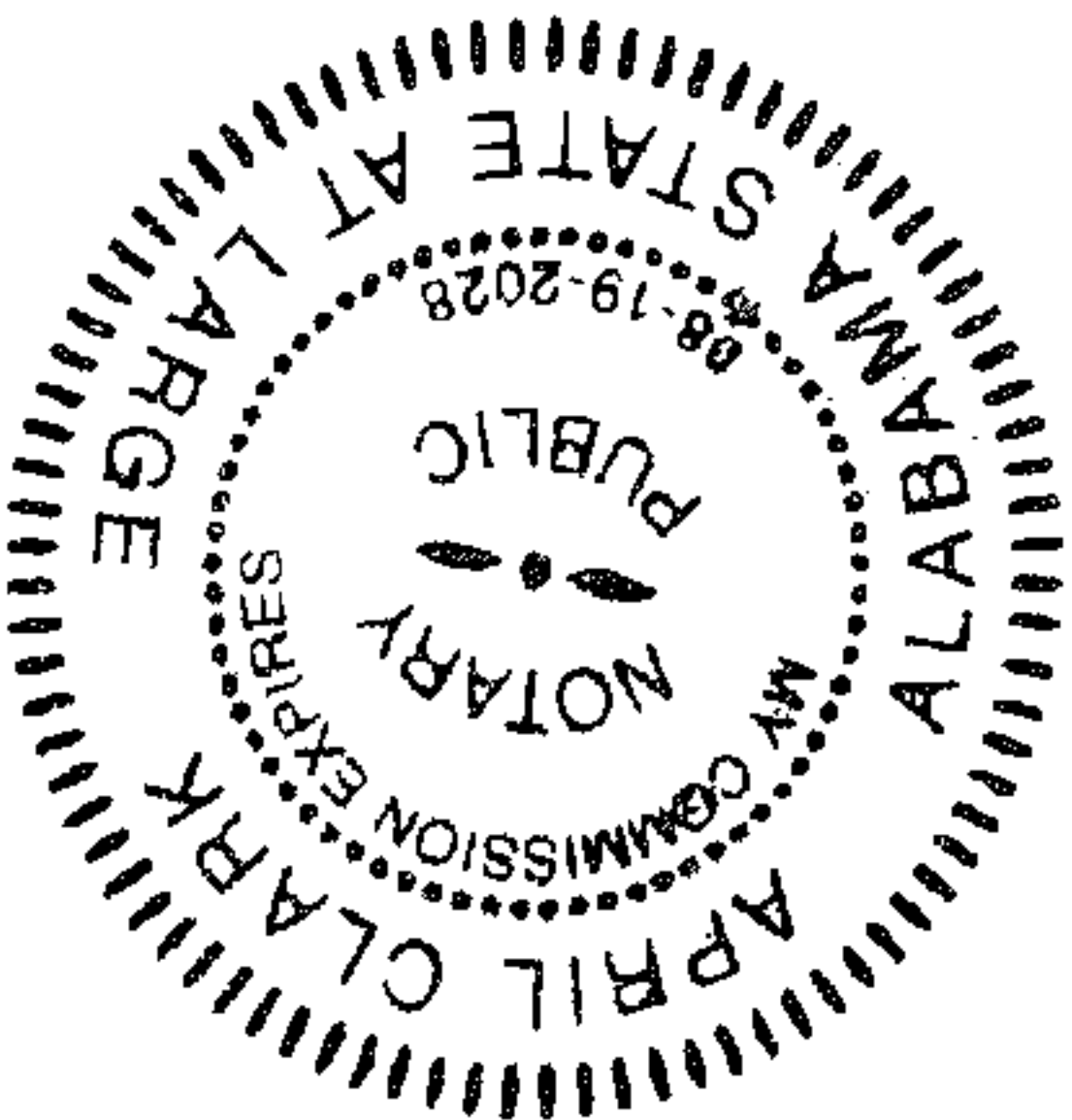

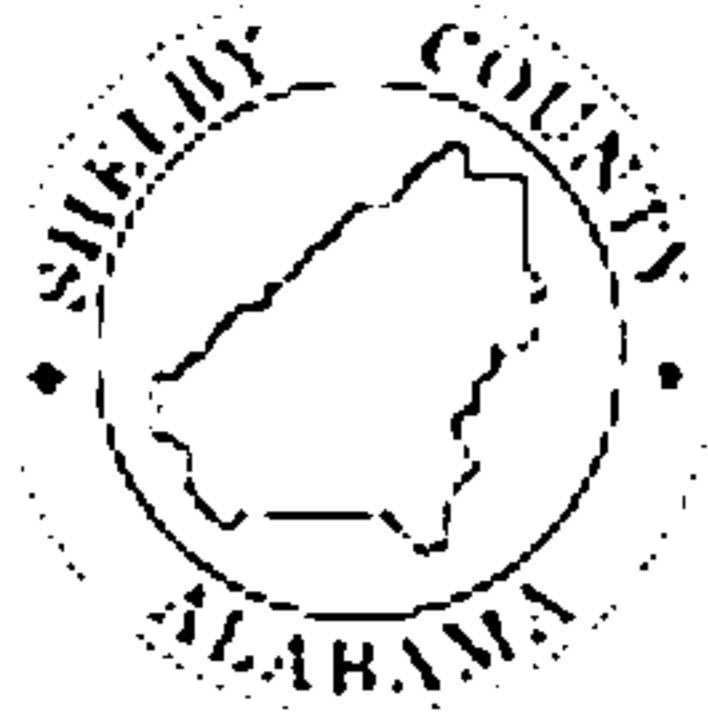
