- All furniture, furnishings, equipment, machinery, goods (including, but not limited to, crops, farm products, 4. timber and timber to be cut, and extracted minerals); (ii) insurance proceeds, accounts, contract and subcontract rights, inventory; (iii) all refundable, returnable, or reimbursable fees, deposits or other funds or evidences of credit or indebtedness deposited by or on behalf of Debtor with any governmental agencies, boards, corporations, providers of utility services, public or private, including specifically, but without limitation, all refundable, returnable, or reimbursable tap fees, utility deposits, commitment fees and development costs, any awards, remunerations, reimbursements, settlements, or compensation heretofore made or hereafter to be made pertaining to the Realty, Improvements, fixtures, or personalty, including but not limited to those for any vacation of, or change of grade in, any streets for the benefit of the Realty or Improvements and those for municipal utility district or other utility costs incurred or deposits made in connection with the Realty or Improvements; and (iv) all other personal property of any kind or character as defined in and subject to the provisions of the Uniform Commercial Code (Article 9 Secured Transactions); any and all of which are now owned or hereafter acquired by Debtor, and which are now or hereafter situated in, on, or about the Realty or Improvements, or used in or necessary to the complete and proper planning, development, construction, financing, use, occupancy, or operation thereof, or acquired (whether delivered to the Realty or Improvements or stored elsewhere) for use in or on the Realty or Improvements, together with all accessions, replacements, and substitutions thereto or therefor and the proceeds thereof;
- 5. All easements, rights-of-way, access, air and development rights, minerals and oil, gas and other hydrocarbon substances, royalties, water, water rights and water stock, and all other rights, hereditaments, privileges, permits, licenses, franchises and appurtenances now or hereafter belonging or in any way appertaining to the Realty or Improvements;
