Tidmore* (herein referred to as *Grantor*) grant, bargain, sell and convey unto *Clinton Randall Crumpton and wife Gina Cheyenne Crumpton, as joint tenants with right of survivorship* (herein referred to as *Grantees*), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

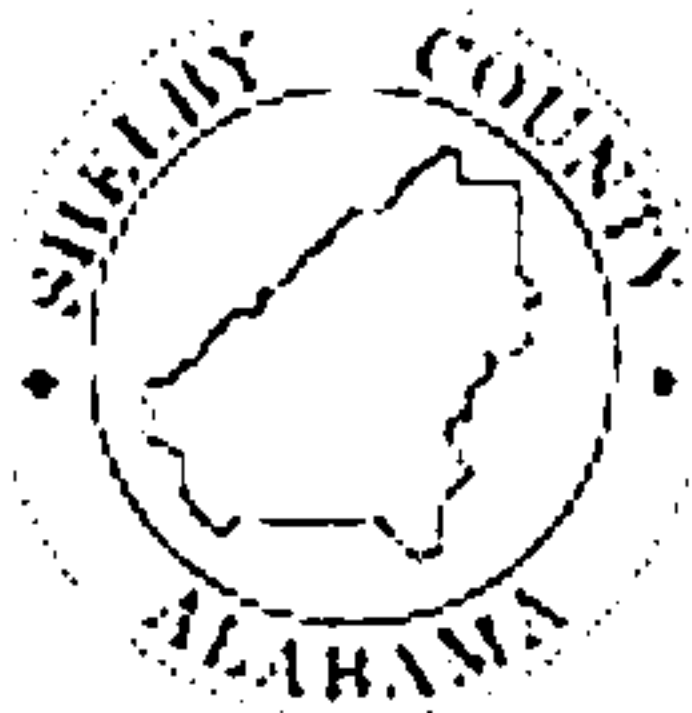

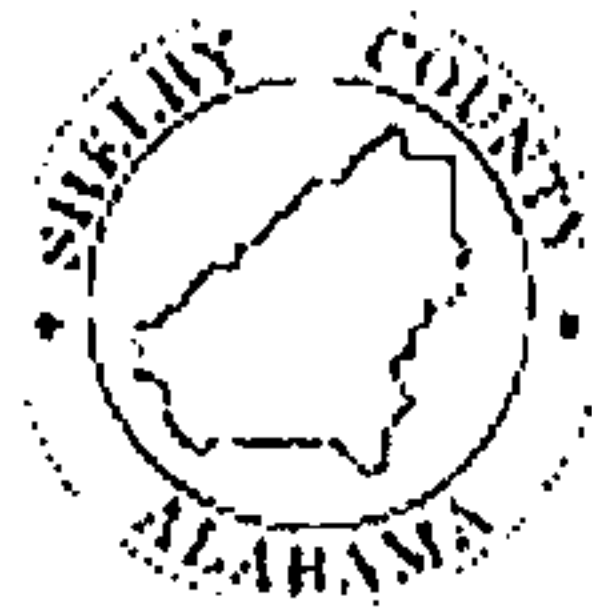
