**\$325,600.00 of the above-recited consideration is being paid with proceeds from a purchase money mortgage being recorded simultaneously herewith.**

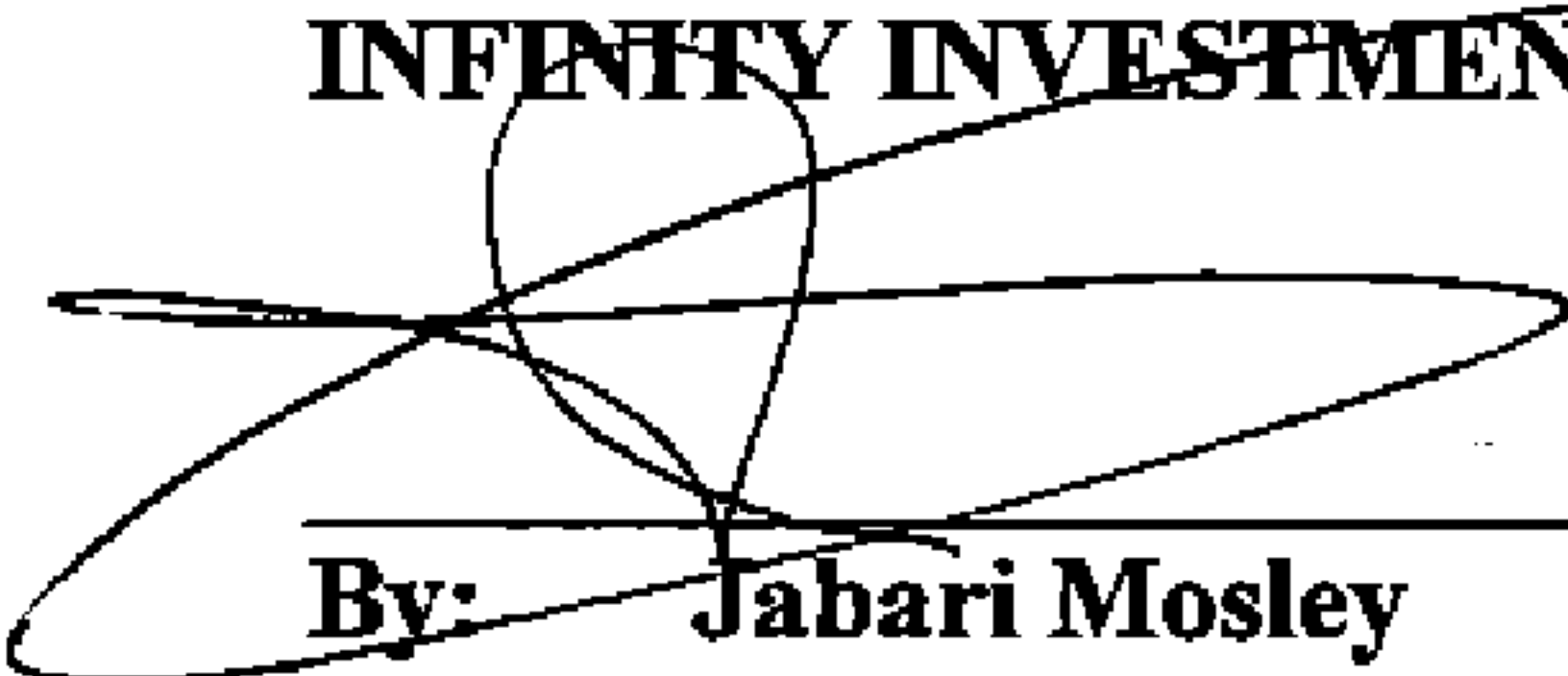

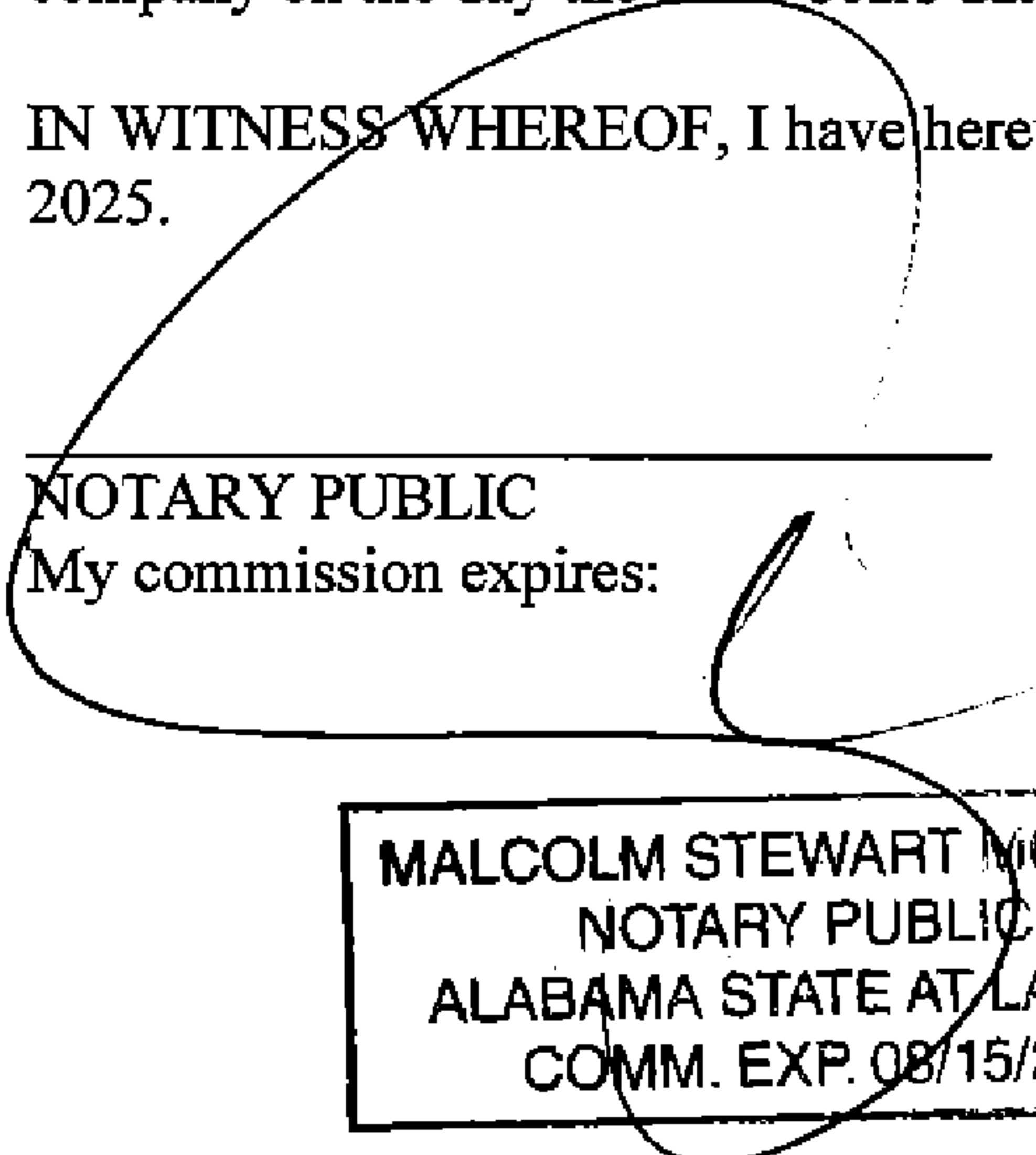

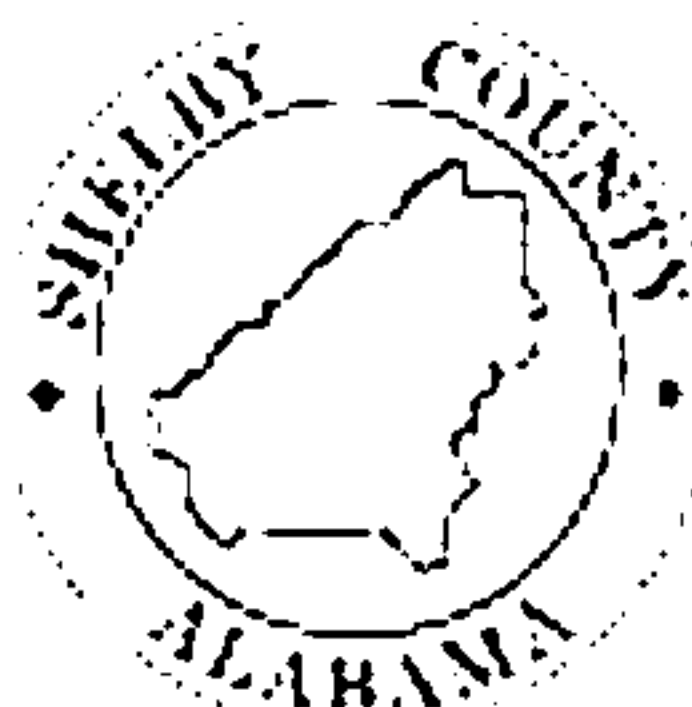
