I have caused these LETTERS OF GUARDIANSHIP AND CONSERVATORSHIP to issue in favor of Laura Hill in and upon the Estate, real and personal property of **JOHNNY STEVEN MOORE**, an incapacitated person and, in every case which occasion may require, the said guardian and conservator is authorized and directed to exercise the powers and duties of Guardian, as articulated under Section §26-2A-78(b) and (d) and Section §26-2A-108, Code of Alabama, (1975) and as Conservator as articulated under Section §26-2A-152 and §26-2A-153, Code of Alabama (1975). It is further ordered that *"the Conservator shall have the authority to execute any documents necessary to create a first-party special needs trust with a pooled trust company, pursuant to 42 U.S.C. §1386p(d)(4)(C) or a qualified income trust, in the event the Conservator determines that such actions are needed for the ward to be eligible for Medicaid benefits."* Any letters previously issued are hereby rendered void as of this date.

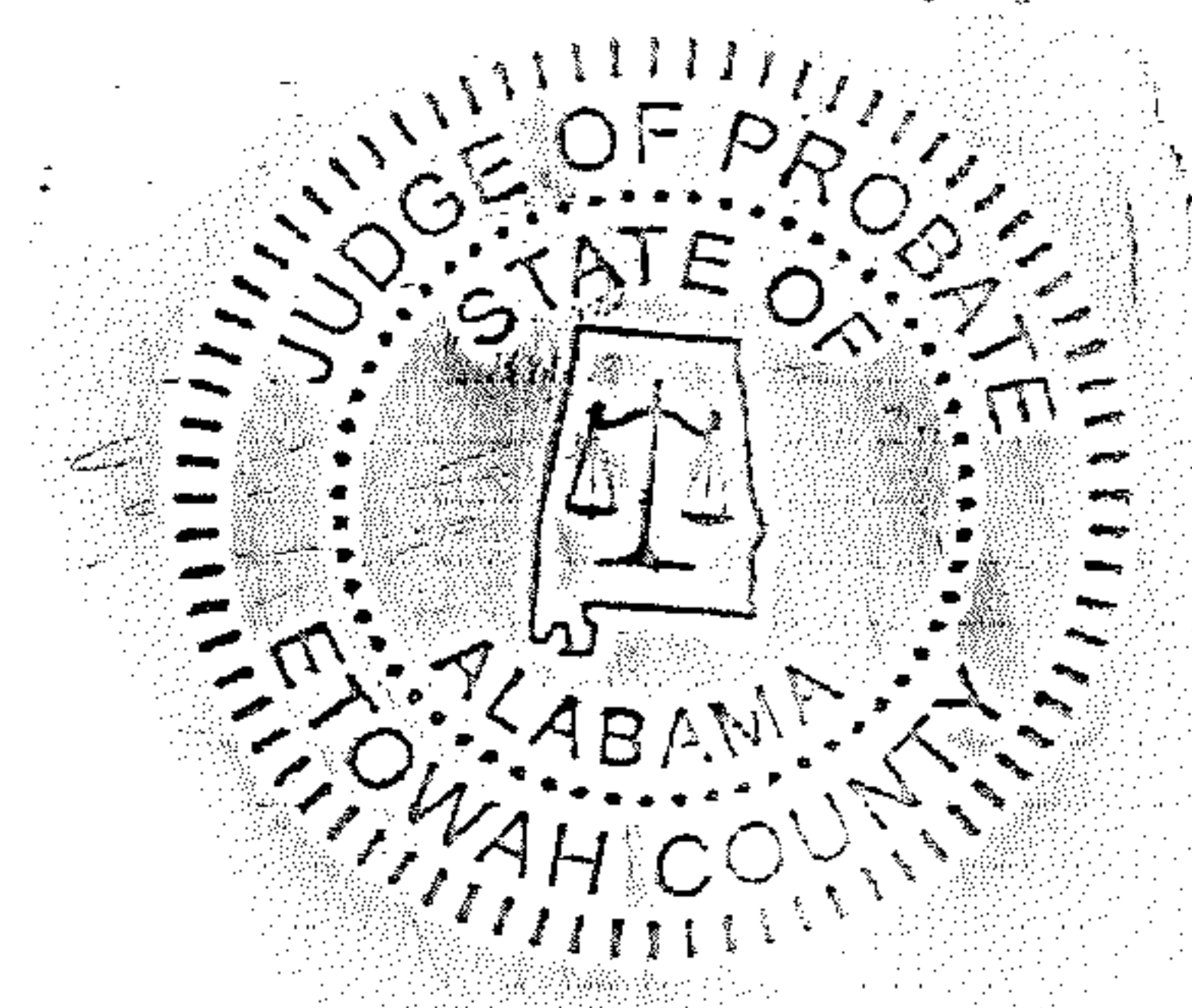




ORDER TO SALE REAL PROPERTY IN CONSERVATORSHIP

THIS MATTER HAVING COME BEFORE THE COURT on the Motion of the Conservator of the Estate of **JOHNNY STEVEN MOORE**, for an Order to approve the sale of the real property located at 1180 Berwick Road, Hoover Alabama, a waiver and consent being offered as evidence and the sale price being more than the appraised value as determined by the Shelby County Revenue Commissioner. The incapacitated person was present in open court, represented by Vincent Pentecost Esq. as Guardian ad Litem. Further, the Court has conferred with Counsel for all parties and understands that there is no objection to the sale of the same. Proceeds from the sale shall cure any debts outstanding with the remainder to be used for the care and support of the Ward. The Court is satisfied that service and/or consent in this matter has been perfected. The Court finds the Motion is well taken and due to be granted.

IT IS THEREFORE ORDEREED, ADJUDGED AND DECREED by this Court the following:

1. The property be sold for \$280,000.00 in accordance with the current offer in hand and Laura Hill, as Conservator of the Estate of **JOHNNY STEVEN MOORE**, be authorized to execute the deed conveying the property upon the full payment of the purchase price;
2. The Conservator shall notify the court upon completion of the sale and verify the disposition of funds and their use thereof.
