WEAVER** (herein referred to as Grantors) grant, bargain, sell and convey unto **KATHERINE HAIRSTON RAINES, KATHEY NEELY HARTHERN and PAUL HARTHERN** (herein referred to as Grantees), the following described real estate, situated in **SHELBY County, Alabama**, to-wit:

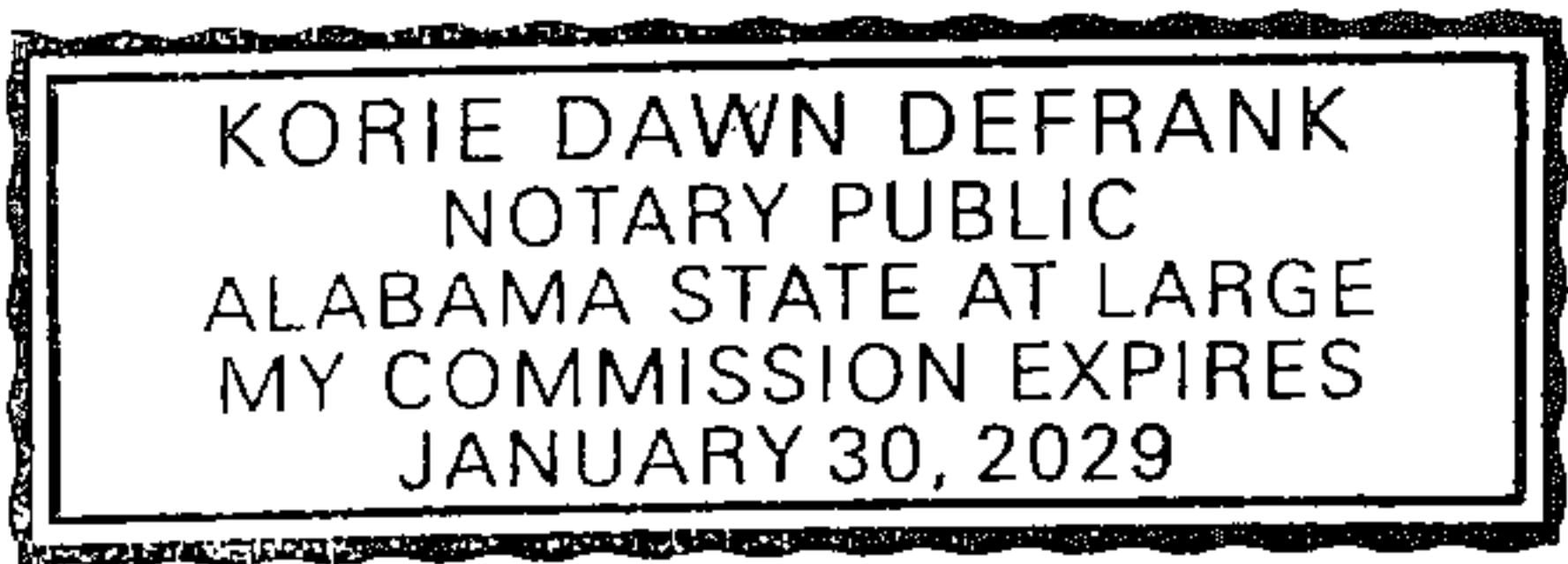
