THE PROPERTY IS AND REMAINS THE HOMESTEAD OF THE GRANTOR.

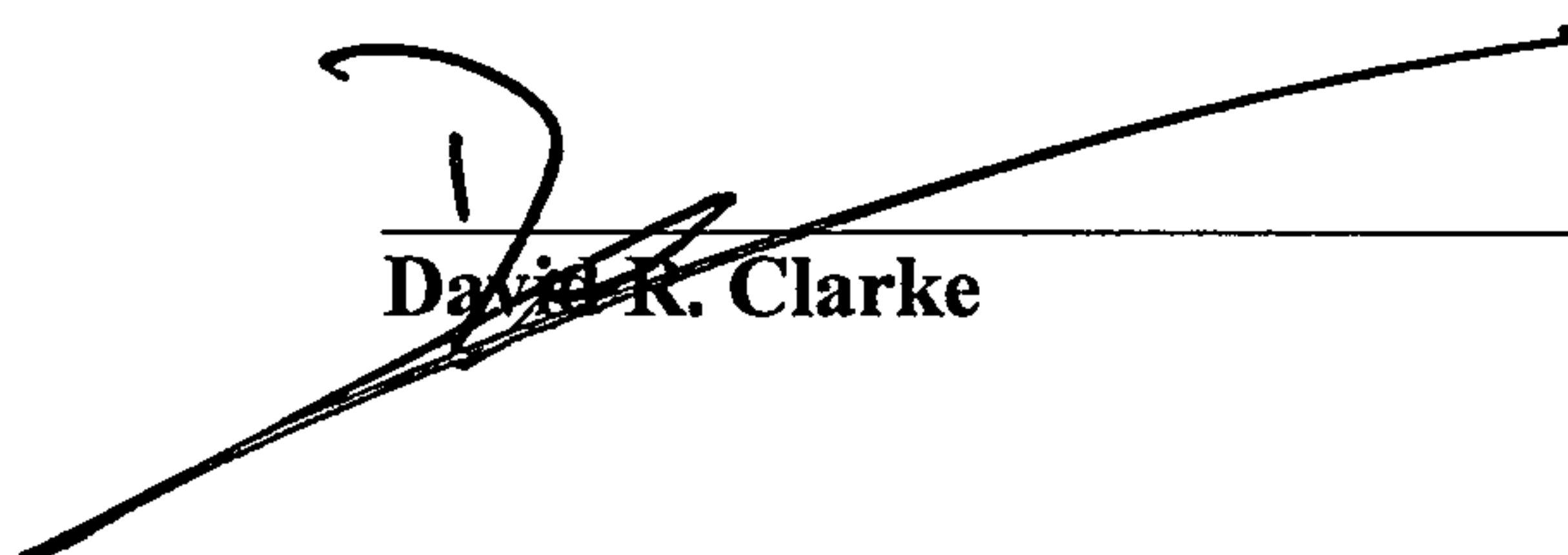
