- This Final Settlement was made for the purpose of discharging the Conservator's surety, Travelers Casualty and Surety Company of America an allowing the Conservator to secure a bond through RIA Bonds located in Pelham, Alabama.

It is therefore, ORDERED, ADJUDGED and DECREED by the Court as follows:

- 1. The Final Settlement of actions taken under the Travelers Casualty and Surety Company of America by the Conservator is due to be and hereby is approved and accepted as filed.
- 2. Travelers Casualty and Surety Company of America is discharged and released

- 3. Letters of Conservatorship issued to Jennifer Anne Bryan Bailey are REVOKED and shall be reissued immediately upon the filing of a bond for a total penalty of Six Hundred Sixty Five Thousand Nine Hundred Dollars (\$665,900.00).
- The Conservator shall file a <u>triennial accounting</u> in this matter on or before <u>March</u> 15, 2029 for the period of January 22, 2025 through January 31 2028.
- Costs of court, including a guardian ad litem fee, are hereby taxed to the estate of Cynthia Suzanne Humber.
