Know All Men by These Presents: That in consideration of **Three Hundred Twenty-Eight Thousand and 00/100 Dollars (\$328,000.00)**, to the undersigned Grantors, in hand paid by the Grantees herein, the receipt where is acknowledged, we, **MATTHEW T. This property does not constitute the homestead of the grantors as defined in §6-10-3, Code of Alabama (1975).




\$322,059.00 of the purchase price herein above has been paid by a purchase money mortgage loan closed simultaneously herewith.

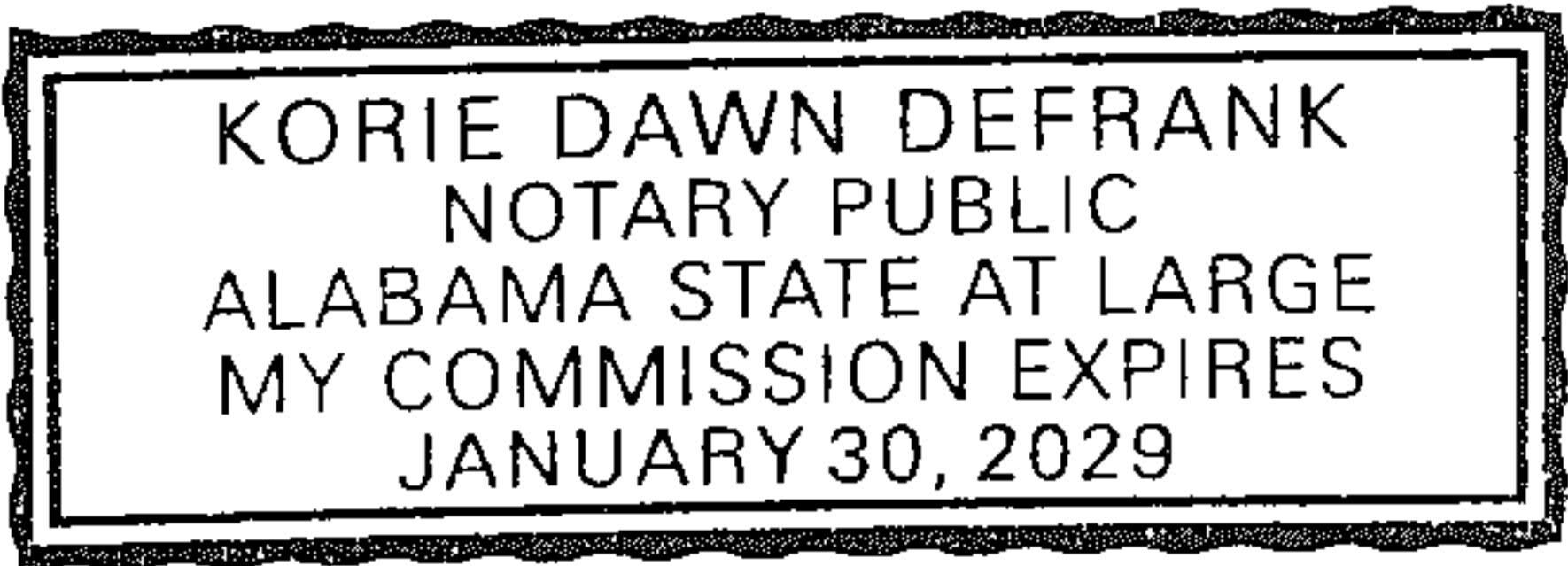


